Life Membership Board of Trustees approved the following will be the 2019 Life Member payout. The National Council of Administration concurred in that payout at its March 5, 2018 meeting.

>Plan ABC - A total payout of \$10.44 for each life member (\$3.48 to each Post, Department and National).

>Plan D - A total payout of \$11.58 for each life member (\$3.86 to each Post, Department and National).

>Plan E - A total payout of \$22.50 for each life member (\$7.50 to each Post, Department and National).

As indicated in the By-Laws, payment will be made in September 2018 for all Life Members recorded as of August 31,

Allow me to address the negative personnel above. But I need your help. I need your membership. Your membership helps the National Commander when



CONVENTION RULES AND PROCEDURES

"The presiding officer of this 99th Annual Convention shall be the Department Commander or any person he may delegate as a temporary chairman during any session."

"The minimum number of delegates required to constitute a quorum for the transacting of business at the State Convention shall be not less than one (1) delegate each from ten (10) posts in the Department. Once established in a session, a quorum shall be deemed to exist unless challenged from the floor by a delegate."

"The Convention will be governed by Robert's Rules of Order 11th Edition except where they conflict with our Department Charter and By Laws or a specific provision of these rules."

"The Convention will proceed in order of business as stated in the convention program."

"Business requiring the action of elected Department delegates shall be the only business of this State Convention."

"Where time of recess has been set up, recess time shall be as stated by the chair; and when recess has been declared, the order of business on hand at the time of recess shall be the first order of business of the next session."

"All committee reports shall be accepted or rejected by a motion on the floor."

"In addressing the chair, the delegates shall first rise and identify themselves by name, post number and district, and speak from a microphone." (There are three microphones set up in the aisles. They are numbered 1, 2 and 3).

"No delegate shall speak more than twice on any subject and the speaker shall be limited to five (5) minutes. A motion shall be in order at any times to limit the debate or discussion on any subject; provided however, that a motion is passed by two-thirds (2/3) vote of the delegates present and voting. The person reporting for a committee or a maker of a motion shall be permitted three (3) minutes rebuttal time unless overruled by the chairman. Any delegate desiring a roll call on any subject on the floor may so move and if supported by three (3) posts, the roll call will be called."

"If the chair is in doubt on a voice vote or any action, the chair may request a roll call vote."

"The decision of the chair shall be final unless an appeal is made. Appeals of the decisions of the chair shall be requested by at least five (5) or more posts representing at least three (3) or more districts."

"At the request of the chairman, the



Parliamentarian shall advise the chair in matters of Parliamentary Procedure, but the decision of the chair shall be final unless appealed by the convention."

"Resolutions shall be submitted in writing and shall be signed by a delegate or officer of the sponsoring Post and shall be submitted to the chairman of the Resolutions Committee. No resolution shall be submitted after 11:00 am Saturday, June 9, 2018."

"The chair may refer any and all resolutions held over, back to committee to meet with objectors, then return back to the convention floor."

"Voting: Each member of the Department Convention as those persons defined in Section 504 present at a meeting of the convention shall be entitled to one vote, and an individual possessing more than one (1) qualification for membership in the Department Convention shall have no more than one (1) vote. The delegate or delegates of a post present at a meeting of the Department Convention shall be entitled to vote the full delegate strength to which post is entitled. The Post Commander, or the Senior or Junior Vice Commander functioning in his place as a member of the convention, may, at his option, choose to vote as a delegate rather than as a Post Commander. Should there be a division among delegates representing the post, each delegate present shall cast his pro rata share of the total delegate voting strength of the post. A roll call may be required and entered upon the record of the Department Convention at the call of any three (3) officers or delegates representing three (3) different posts."

"Election of Department Officers will be called for at approximately 3:00 pm Saturday, June 9, 2018."

"Posts that are under suspension in the opening of the State Convention will not be eligible to vote. Post suspension will not be lifted after the convention has opened."

"Posts that are in arrears to Department for poppy orders; posts that are not bonded; posts that have not submitted an election report of officers; posts that have not paid their Department Convention delegate fees; or Posts that are delinquent for any quarterly report of trustees audit will not be eligible to vote under Section 213 of the National by laws. Post eligibility to vote will be restored immediately upon receipt of evidence of resolution of the deficiency."

At this time, these are the posts with outstanding obligations to the department:

All cell phones shall be turned off or placed in the vibration mode. Any conversations on cell phones shall be conducted outside of the convention floor unless pre-approved by the chairman.

Registration shall close on Saturday at 11:00 am.

until proof of eligibility has been submitted and properly reviewed. Post-Election Reports must be submitted following Post election of officers in April and no later than June 1 to the National Headquarters. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post-Election Reports received electronically will be forwarded to the Department Headquarters. Posts that do not do election reports via VFW website are to forward them to the State Adjutant.

Post Commanders are directed to Section 222 of the National By-Laws and the Manual of Procedure, which provides that each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that was mailed to all Posts as part of the Election Report/Convention Registration mailing that went out in February. Advanced registration for the 119th National Convention should be mailed with each delegate's name and address to: Convention Registration, 406 West 34th Street, Kansas City, MO 64111.

Section 222 of the National By-Laws and the Manual of Procedure: Provides that Posts shall elect delegates and alternates to District conventions at a regular meeting of the Post held not less than thirty (30) days prior to the District convention at which District officers are to be elected: one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at the time of the election. Delegates and alternates to the Department conventions shall be elected at a regular meeting of the Post held not less than thirty (30) days prior to the Department convention. Posts are entitled to one (1) delegate and one (1) alternate for

each thirty (30) members or fraction thereof in good standing in the Post at the time of the election.

Any Post in arrears for National, Department or District dues, Poppy monies, supply monies, or other financial obligations, or failing to have the Quartermaster properly bonded, or failing to submit properly completed Quarterly Post Trustees Report of Audit or Post Election Report shall be deprived of all representation in District, Department and National Conventions. Representation will be restored upon proper adjustment of such deficiencies.

Internal Revenue Service Form 990: Post Commanders should ensure that information returns are filed annually on Form 990. These forms may be obtained by calling Federal Tax Forms & Publications hot-line @ 800-829-3676. The forms must be filed on or before the 15th of the fifth month following the close of the respective annual accounting period. If gross receipts are \$50,000 or less, you need to file e-postcard 990N online. The IRS asks ONLY the heading on page one to be completed, being sure to check Box B and send it to the Ogden IRS Center, Ogden, UT 84201.

Members are reminded that their annual membership in the Veterans of Foreign Wars is now subscription based and expires on their anniversary date. All officers are encouraged to make every effort to renew the membership of each and every continuous member prior to their expiration. Reports showing members 30, 60, and 90 days from expiration can be obtained by the Post Quartermaster through the Online Membership System (OMS). Commanders: On all levels are reminded that according to Section 105 of the National By-Laws, a member whose dues are unpaid after their anniversary date ceases to be a member in good standing and loses all rights of membership in the Veterans of Foreign Wars. They shall not attend meetings or conventions and shall not participate in Post, County Council, District, Department or National functions.

Thank you for all you do on a daily basis for your Post, County Council, District and Dept. of MI VFW.

Remember that all audits must be completed within 30 days of the completion of the Quarter. You must have the signatures of the 3 trustees and the Commanders signature on the Audit before you submit it to Department.

Also for the Trustees line 15 and 17 must match. The ending balance of the previous quarter must be the beginning balance of the new quarter. This is a big issue throughout the department.

Also the national by-laws (219) state a RELIEF fund will be established and maintained by the POST. Comrades the audit is a very important part of the post and needs to be accurate.

If you need any assistance contact the district personnel first then contact me or the department. The district officers are there to assist you so don't be afraid to ask for help.

Upon elections for all the new Trustees and Quartermasters please make sure that they attend a VTS training session to help with their position the first one is June 23rd at Camp Trotter in Newaygo cost of \$30.00 person includes meals.

He became a life member of the VFW in 2010 and serves as Senior Vice Commander, Legislative Chairperson, and Community Activities Chairperson at James Europe Post 2233 in Detroit. Ben represented his post as a delegate for both the State Convention and National Convention in New Orleans. Ben is married to Leah Light. Department Service Officers SUCCESS STORY

As often happens when meeting with a prospective client you may be pleasantly surprised at the final outcome of a claim. Our service officer met with the daughter of a surviving spouse at an assisted living facility. The widow was relocating back to Michigan after having suffered a stroke that left her with debilitating health issues and unable to live on her own. The daughter was seeking information on any form of assistance her mother might be qualified for.

After obtaining the basic information needed to initiate the claim our service officer learned the widow had received benefits shortly after her husband's death in 1995. This bit of information was critical to the overall claim. The widow had been in receipt of survivor's pension until she was eligible to receive social security benefits. After that the widow was making ends meet with her social security benefits alone...and then the stroke happened.

Upon reviewing the DD 214 the service officer learned the veteran had served in Vietnam. Attention was immediately directed at the death certificate which indicated the veteran passed away as a result of heart disease. Heart disease is recognized by the Department of Veterans Affairs as a presumptive disease associated with Agent Orange exposure.

There was no question in the mind of the service officer concerning the widow's eligibility to receive Dependency and Indemnity Compensation (DIC). DIC is a tax free monetary benefit paid to eligible

survivors of military Service members who died in the line of duty or eligible survivors of Veterans whose death resulted from a service-related injury or disease. What was a matter of keen interest was how far back the VA would go for awarding the benefit.

This is not a question easily answered for many. The widow filed the claim in October 2017 so many would consider the date of claim as the effective date. In some cases the VA will recognize the effective date one year prior to the date of claim. At other times the VA will consider the date the law went into effect. Ischemic heart disease was added to the presumptive disease list in October 2010. Confused yet? Now you know why our service officers undergo such specialized training.

There is yet another situation that allows the VA to award an effective date before an illness was added to the presumptive list. In this case it was when the widow initially filed for survivor's benefits in January 1995. That's right. Even though the widow filed for DIC in 2017 the VA awarded her back to the initial date of claim in 1995. The widow received a payment for over \$175,000! And that's not all. Because the stroke left her in need of the aid and assistance (A&A) of another person to cope with the activities of daily living the widow qualified for the A&A enhancement which adds \$317.87 to the monthly benefit. Despite her unique health challenges the surviving spouse will be able to enjoy a comfortable quality of life. No one does more for veterans ...or their surviving spouses.





In 1995, Indiana Governor Evan Bayh bestowed the honor of naming him a Distinguished Hoosier, and Governor Joe Kernan awarded Bill the Sagamore of the Wabash Chieftain in 2004. Kentucky Governor Steven Beshear commissioned him a Kentucky Colonel in 2012.

Mr. Thien is a member of the American Legion, DAV, Veterans of Vietnam War Inc., Military Order of the Cootie Pup Tent 51 and VFW National Home.





On February 27, at 6pm Post 4090 honored Mr. John Dorsky as their Veteran of the Year.

Before the award was presented, Commander William Almy read the following achievements to a packed room of veterans, auxiliary and family.

"As a young man, John joined the Air Force after graduating from high school in Baraga, Michigan in 1951. He served in the Korean War from 1952 through part of 1953. He completed his military duty November 14, 1953 while stateside.

John's first introduction of Post 4090 came in 1970, when a fellow veteran stated, "You should visit our post, they have liquor there".

He joined the post February 10, 1972 and became a life member December 19, 1977.

John first served as post quartermaster and then post commander in 1982 – 1983. During his many years with Post 4090, he served as post service officer, Trustee, Voice of Democracy chair, and County Council Commander for the 1985 – 1986 year.

At District 9 level, he marched through the chairs on his way to being elected District 9 commander for the 1988 and 1989 term. While at the district level, his dedication continued with many appointments. John worked closely with Wes Longinbaugh setting up the Patriot Pen essay program for the posts of District 9. The program became so popular that it expanded to state and national level. In addition, at the District 9 he served as Cancer director, State inspector, all State director and was one of the architects of the first Activities Evaluation Committee, a program that is in use to this day.

In the year of 2002 – 2003 John received the Raymond G. O'Neal award for state service officer of the year. John states; "of all my duties and responsibilities, being service officer was the one thing I cherished the most."

John has served as Post 4090's Funeral Honor Guard chairperson, a position he has held for over 25 years.

Long time funeral director Keith Neller stated – "I have worked with John for at least 25 years, and one thing I remember about his funeral detail is, they were always on time, always signed the register and the men always followed protocol and procedure with dignity and honor."

It should be obvious to us all that his loyalty and dedication to family, to his Post and the Veterans of Foreign Wars are a measure of hard work that all of us can appreciate."

Resolutions Passed at State Conventions Sometimes Work

Every year VFW Posts and other veteran service organizations across the America receive calls from disgruntle survivors of veterans whose grave were not marked by a flag on Memorial Day weekend. In most cases the current marker that is in place is a commercial one and is void of any indication that a veteran is even interred there.

For the better part of the two decades the Department of Michigan, VFW through its State Conventions has passed resolution after resolution that were sent to our National Convention floor to try to alleviate this situation.

Some would say that it is not a big deal to have a veteran's grave marked with a flag. Tell that to the families who will finally have their loved one remembered for their military service!

Getting the Federal Government to change procedure can be a monumental task. Around 1998, the Department of Michigan, VFW began submitting resolutions indicating:

- Government headstones should be available to all who request;
- There is to be no consideration given to the circumstance if a grave has a commercial headstone or not;
- There is to be complete elimination of any date that prohibits the government marker from being placed on a marked grave with a commercial marker.

Year after year, resolutions were submitted at the Department of Michigan, VFW Conventions. Year after year, our position was pressed at the VFW National Conventions.

The following summary gives an historical perspective of how the mountain was moved:

Prior to September 11, 2001

- Policy: A government headstone could only be requested for an "unmarked grave of a veteran."
- Reality: Many cemetery sextons interpreted "unmarked" loosely. If nothing on the commercial headstone identifying the deceased as a veteran, application was made for the headstone.
- Result: The Department of Veterans Affairs issued policy regulations addressing the matter. Consequentially, fewer families received the government headstone for their loved one.

December 6, 2002

- Public Law 107-103, title V, Section 502 (a)-(c)
- Policy: Removed requirement that the grave must be "unmarked"
- Reality: Stipulation went back only to September 11, 2001

December 26, 2007

- Public Law 110-157, title II, sections 201,203 (a)
- Policy: The creation of the Medallion for commercial markers in lieu of a government headstone.
- Retroactively went back and established November 1, 1990, as the date that would be allowed both government headstones and/or commercial markers.
- There still was no eligibility for the Medallion prior to November 1, 1990.

For the next ten years the Michigan VFW continued to go through with the resolutions at the State Conventions and on to the National Conventions. However, we changed our strategy when the Medallion was created. In an act of fiscal responsibility, it was our opinion that we change our resolution to address only the Medallion due to the cost of headstones versus medallions.

The following is the resolution that we continued to push forward each year at the State Conventions and on to the National Convention. In fact, the Veterans of Foreign Wars of the United States adopted the resolution as a Commander-In -Chief resolution in the latter years before enactment from Congress.

MARKER MEDALLION

WHEREAS, Public Law 110-157, signed into law on December 26, 2007 gives the VA authority to "furnish, upon request", a medallion or other device of a design determined by the Secretary, to signify the deceased's status as a veteran, to be attached to a headstone or marker that was furnished at private expense; and

WHEREAS, veterans who died prior to November 1, 1990 are not eligible to have this medallion or other device provided; and

WHEREAS, family headstones or monuments often do not necessarily commemorate the veteran's military service; and

WHEREAS, many of our honored deceased veterans now lie in their final resting place without lasting testimony by our government of their service to our country; and

WHEREAS, we believe this injustice to our Nation's veterans must be corrected; now, therefore

BE IT RESOLVED, by the Veterans of Foreign Wars of the United States, that we support amending Public Law 110-157 to require the Department of Veterans Affairs to furnish a medallion or other device notwithstanding that fact that they died prior to November 1. 1990.

In the early part of 2016, the VFW National Legislative Service testified before Congress the need to support and address this injustice. Public Law 114-315, title III, section 302, dated December 16, 2016, referred to as the "Jeff Miller and Richard Blumenthal Veterans Health Care and Improvement Act of 2016," retroactively adjusted the eligibility date for requesting a Medallion for a commercial headstone of a marked grave to April 7, 1917, the beginning of World War I.

The effective date of this law took effect on December 16, 2017 and the new form 40-1330M was published online on March 20, 2018. How appropriate that during the 100th Anniversary of the end of WWI, the Michigan VFW can celebrate such an accomplishment! Many WWI veterans were buried in family plots throughout our nation with just their first name on a stone. No markings of military service at all.







"Began again to Smooth the Face of the Lawn, or Bolling [sic] Green on the West front of my House..."

Washington Diary Entry, September 30, 1785

George Washington devised, as the central element of his landscape composition, a level, well-manicured lawn, admirably described by one French nobleman as "a kind of courtyard with green carpet." While modern visitors may be accustomed to such wide expanses of evenly trimmed grass, 18th-century lawns were expensive to plant and required extensive labor to maintain. The gently curving perimeters gave the landscape a more natural appearance, strongly contrasting with the straight, formal walks of most 18th-century American landscapes. To maintain its appearance, the grass was regularly smoothed with a large stone roller and cut with scythes by skilled enslaved laborers.

Wood That Looks Like Stone

The Mansion, constructed of wood, appears to be made of stone; an effect called rustication. The pine siding boards were cut and beveled to resemble stone blocks. After paint was applied to the boards, sand was thrown onto their wet surfaces to create a stone-like texture. In addition to making the Mansion appear more substantial and expensive, the sand-painted surface wore well and protected the wood siding boards.

The warm buff color of the Mansion today replicates its appearance after the last round of sand painting ordered by Washington in 1796. He instructed his farm manager, James Anderson, to use crushed sandstone from the nearby Aquia Creek, instead of the lighter colored Chesapeake Bay beach sand that was previously applied. In 2011, Mount Vernon staff reintroduced off-white paint and Aquia sand, consistent with 18th-century practice.

So that we are perfectly clear, the following applies for any request for government headstones, markers, and medallions:

The Department of Veterans Affairs (VA) furnishes upon request, at no charge to the applicant, a Government headstone or marker for the unmarked grave of any deceased eligible Veteran in any cemetery around the world, regardless of their date of death. VA may also furnish a headstone or marker for graves marked with a private headstone or marker, for Veterans who died on or after Nov. 1, 1990.

Any deceased Veteran discharged under conditions other than dishonorable and any member of the Armed Forces of the United States who dies on active duty may be eligible. Service after Sep. 7, 1980, as an enlisted person, and service after Oct. 16, 1981, as an officer, must be for a minimum of 24 months continuous active duty or be completed under special circumstances (e.g., death on active duty). Persons who have only limited active duty service for training while in the National Guard or Reserves are not eligible unless there are special circumstances (e.g., death while on active duty or because of training). Reservists and National Guard members who, at the time of death, were entitled to retired pay, or would have been entitled, but for being under the age of 60 are eligible. Reservists called to active duty other than training and National Guard members who Federalized and who serve for the period are called are eligible. Service prior to World War I require detailed documentation (e.g., muster rolls, extracts from State files, military or State organization where served, pension or land warrant, etc.). Spouses and dependents are not eligible for a Government-furnished headstone or marker unless they are buried in a national, state Veterans', or military post/base cemetery.

The VA furnishes a medallion, upon request, to be affixed to an existing, privately purchased headstone or marker to signify the deceased status as a Veteran. This device is furnished in lieu of a traditional Government headstone or marker for Veterans who served on or after Apr. 6, 1917, and whose grave in a private cemetery is marked with a privately purchased headstone or marker.

Any deceased Veteran discharged under conditions other than dishonorable who served in the Armed Forces on or after Apr. 6, 1917 or any member of the Armed Forces of the United States who dies on active duty and is buried in a private cemetery in a grave marked with a privately purchased headstone or marker may be eligible. Service after Sep. 7, 1980 must be for a minimum of 24 months continuous active duty or be completed under special circumstances (e.g., death on active duty). Persons who have only limited active duty service for training while in the National Guard or Reserves are not eligible unless there are special circumstances (e.g., death while on active duty or because of training). Reservists and National Guard members who, at the time of death, were entitled to retired pay, or would have been entitled, but for being under the age of 60 are eligible. Reservists called to active duty other than training and National Guard members who are Federalized and who serve for the period called are eligible.

There are literally tens of thousands of veterans' graves that do not acknowledge their service. It is up to each VFW Post to search and find those graves. Please work with our VFW Service Office, your County Office of Veteran's Affairs, and cemetery sextons to assist in locating and identifying those deceased veterans' graves. Secure as much information as possible before applying for a medallion.

This mission began several years by the Department of Michigan Veterans of Foreign Wars and it is now up for the membership to carry the torch and once again validate that **"No One Does More for Veterans,"** than the **Veterans of Foreign Wars of the United States.**

WHO CAN APPLY - An "applicant" for a Medallion may be any of the following:


- A decedent's family member, which includes the decedent's spouse or individual who was in a legal union as defined in 38 CFR 3.1702(b)(1)(ii) with the decedent; a child, parent, or sibling of the decedent, whether biological, adopted, or step relation; and any lineal or collateral descendant of the decedent;
- A personal representative, defined as a family member or other individual who has identified himself or herself as the person responsible for making decisions concerning the interment of the remains of or memorialization of a deceased individual;
- A representative of a Congressionally-chartered Veterans Service Organization;
- An individual employed by the relevant state, tribal organization, or local government whose official responsibilities include serving veterans and families of veterans, such as a state or county veterans service officer; or
- Any individual who is responsible, under the laws of the relevant state or locality, for the disposition of the unclaimed remains of the decedent or for other matters relating to the interment or memorialization of the decedent.


