Many of them are WWII veterans that should have been helped years ago. They just didn't know the help was available.

Michigan's No Smoking Law Effective May 1, 2010

Subject: No Smoking Law Compliance

**Non-Exemption
(No Michigan Post is Exempt)**

The Veterans of Foreign Wars, Department of Michigan, hereby notifies all Michigan Posts and/or lounges, they are **not exempt** from the State's new no smoking legislation as passed by the Michigan Legislature and signed into

law by Governor Jennifer M. Granholm and are expected to be in compliance. Michigan is now the 38th state to adopt this type of no smoking law.

Effective May 1, 2010, the Michigan Public Code is amended to prohibit smoking in public places, in places of employment, and in food service establishments.

The new law further requires that a no smoking sign or the international no smoking symbol be clearly and conspicuously posted at entrances to and within every building.

Additionally, the new law requires that ashtrays and other smoking paraphernalia be removed.

Thank you for your compliance.

No Foxholes!

In the summer of 2006, one of our staff members had the opportunity to participate in the Annual Memorial Day Services conducted at our State Capitol at the request of State Senator, Valdi Garcia. After the service was over, a light luncheon was provided by the good Senator and our staff member was introduced to a WWII veteran from the Greatest Generation, by his son.

In the conversation, time was not an issue; our advocate was captivated by this gentleman who shared his experience from a time when most of us were not born. A time when fighting for the rights of others was not taken for granted. A time when veterans got discharged, they went back to their home towns, got a job, raised a family, and in most cases, did not speak ill of anyone.

As people came and went from the luncheon area and as the veteran's stories came and went, it was apparent that this

veteran had a chronic condition that he may have or may not have ever filed a claim with the Department of Veterans Affairs.

Our advocate told the veteran that if he could, he would help, because it sounded like a valid claim that needed to be developed. In fact, a few days after this learning experience by our staff member, he sent the veteran the necessary paperwork to start what would become a long journey, one where the veteran could never have visualized the outcome.

After a lengthy delay and numerous attempts in securing the veteran's claims file from the Records Storage Center in St. Louis, it finally arrived at the Detroit Regional Office in December 2007. After an extensive review of the file, it was determined that the veteran never filed for the condition. In February 2007, a claim was completed by one of our Field Advocates and finally submitted for the claimed condition.

Almost a year later, the file was transferred to Cleveland, Ohio and assigned to the Tiger Team which had jurisdiction over older veterans' claims. On February 12, 2008 a decision was rendered by the Tiger Team and it wasn't good. The decision was denying the claim because it was a "fire-related" case and that no service medical records were available. This was interesting in itself because the rating decision that denied the claim, listed service medical records as evidence used. Huh!

In a fire at the NPRC (MPR) on July 12, 1973, a disastrous fire destroyed approximately 16-18 million Official Military

Advocating for Others

This past year has been very trying and challenging as we move into the New Year and face a new way of doing business. As you may or may not be aware, the Michigan State Legislature passed Senate Bill 250 and became part of Public Act 112 of 2009.

The provisions of SB 250, Section 501 creates, a five member advisory board made up of two large Veterans Service Organization (VSO's), 2 medium VSO's, and 1 small VSO. A large VSO is defined as one that can certify that its membership exceeds 30,000 members. A medium is defined as a VSO that can certify its membership is between 2,500 and 29,999 members. Finally, a small VSO is defined as a VSO that can certify its membership is between 1,000 and 2,499.

On November 10, 2009 at a meeting of the Commanders Group held in Lansing, and based on the criteria above, the VFW and American Legion automatically were seated on the Advisory Board. The DAV and AMVETS, through a group vote, were selected to fill the medium VSO's and the Marine Corps League, through a vote of the group, was selected as the small VSO.

This Advisory Board met to offer input for the criteria on the grants that the Department of Military & Veterans Affairs (DMVA) would oversee. The initial grants will be for the period of April 1, 2010 to September 30, 2010, and in all likelihood, may be extended through September 30, 2011. This, of course, is all dependent on the economy here in the State of Michigan. The five grants will consist of two large, two small and one specialized grant for paralyzed veterans' issues.

After careful consideration, and in an effort to continue efficient and effective Service Programs here in the State of Michigan, a meeting was held on January 5, 2010 at the DAV Department Headquarters in Fraser, Michigan. State Commander, David Hutson, Adjutant/Quartermaster, Robert Weiss, myself, and the leadership of the following VSO's: The American Legion, Disabled American Veterans, Marine Corps League, and the Military Order of the Purple Heart have agreed to petition as a coalition to the Department of Military and Veterans Affairs for all available grants. With all due respect to the other VSO's involved that are not part of our coalition, we are confident that we can provide the service needed to ensure that the requirements of the grants are met with excellence in the delivery of service.

So, by the time that this article goes to press, our coalition will have submitted our first request for the two large grants by January 20, 2010, and this will be shortly followed in early February, with the second request for the two small grants.

You may wonder how much the grants are going to be. At this time we are anticipating that the two large grants will be \$500,000 apiece. We will not know how much the two smaller ones will be until they are announced.

In my last article, I indicated the following three conditions would be added to the presumptive list as a result of Vietnam service and herbicide exposure – B cell leukemia's, such as hairy cell leukemia; Parkinson's disease; and ischemic heart disease. The regulations governing these conditions and secondary issues have not been published. Until the regulations are in place, claims for these conditions cannot be adjudicated by the Department of Vet-

erans Affairs. Once the Regulations are in place, the VA will process accordingly.

The Department of Veteran Affairs has initiated a program to collect data on Vietnam naval operations for the purpose of providing Regional Offices with information to assist with development in Haas-related disability claims based on herbicide exposure from Navy Veterans. To date, the VA has received verification from various sources showing that a number of offshore "blue water" naval vessels conducted operations on the inland "brown water" rivers and delta areas of Vietnam.

In addition the VA has identified certain vessel types that operated primarily or exclusively on the inland waterways. The ships and dates of inland waterway service are listed below. If a veteran's service aboard one of these ships can be confirmed through military records during the time frames specified, exposure to herbicide agents (Agent Orange) is conceded, and if the veteran has one of the conditions listed in 38CFR3.309 (e), service connection can be granted.

All vessels of Inshore Fire Support [IFS] Division 93 during their entire Vietnam tour:

USS *Carronade* (IFS 1)

USS *Clarion River* (LSMR 409) [Landing Ship, Medium, Rocket]

USS *Francis River* (LSMR 525)

USS *White River* (LSMR 536)

All vessels with the designation LST [Landing Ship, Tank] during their entire tour [WWII ships converted to transport supplies on rivers and serve as barracks for brown water Mobile Riverine Forces]

All vessels with the designation LCVP [Landing Craft, Vehicle, Personnel] during their entire tour.

All vessels with the designation PCF [Patrol Craft, Fast] during their entire tour [Also called Swift Boats, operating for enemy interdiction on close coastal waters]

All vessels with the designation PBR [Patrol Boat, River] during their entire tour [Also called River Patrol Boats as part of the Mobile Riverine Forces operating on inland waterways and featured in the Vietnam film "Apocalypse Now"]

USS *Ingersoll* (DD-652) [Destroyer] [Operated on Saigon River, October 24-25, 1965]

USS *Mansfield* (DD-728) [Destroyer] [Operated on Saigon River August 8-19, 1967 and December 21-24, 1968]

USS *Richard E. Kraus* (DD-849) [Destroyer] [Operated on coastal inlet north of Da Nang, June 2-5, 1966, protecting Marines holding a bridge]

USS *Basilone* (DD-824) [Destroyer] [Operated on Saigon River, May 24-25, 1966]

USS *Hamner* (DD-718) [Destroyer] [Operated on Song Lon Tao and Long Song Tao Rivers, August 15-September 1, 1966]

USS *Conway* (DD-507) [Destroyer] [Operated on Saigon River, early August 1966]

USS *Fiske* (DD-842) [Destroyer] [Operated on Mekong River, June 16-21, 1966]

USS *Black* (DD-666) [Destroyer] [Operated on Saigon River, July 13-19, 1966]

USS *Providence* (CLG-6) [Cruiser, Light, Guided Missile] [Operated on Saigon

Personnel Files. The records affected were Army Personnel discharged from November 1, 1912-January 1, 1960, and Air Force Personnel discharged from September 25, 1947-January 1, 1964 (with names alphabetically after Hubbard, James E.) So this fire affected the veteran's claim.

However, in 1988, a collection of computer tapes containing ten million hospital/treatment facility admission records was transferred to National Personnel Records Center. These records, originally created by the U.S. Army Surgeon General's Office (SGO), were discovered by the National Academy of Sciences and offered to the National Archives for use by NPRC. Between 1988-1990, NPRC was able to salvage 7.8 million records of individuals' admissions for use as a major supplement to other smaller sources of medical information.

In July of 2009, we were finally able to retrieve the file back from the VA to do another review with the SGO records in mind. When the original claim was filed in 2007, the VA requested service medical records, but the fire-related issue became the issue. What the VA failed to do was to review a one page document that was sent

twice. It appeared to the VA that the envelope that it was sent in was empty, but in fact contained the following information: Veteran hospitalized in 1944 for an extended period for the claimed condition.

A letter was sent to the VA by the VFW addressing the above information and requested that the claim be reconsidered and that the original filing date be protected for payment purposes. The file was then brokered to Togus, Maine for a rating decision.

On December 2, 2009, the VA granted the veteran's condition and on December 14, 2009 he got an early Christmas present deposited in his checking account in the amount of \$7,700.

In another conversation with the veteran on January 7, 2009, he called to say thank you and that he never thought that this would ever happen! In fact, he thought our staff member was just "blowing smoke" at him back in 2006. He also stated that we are one of the "good guys" and he wanted the claim to go back to 1945. He was told, unfortunately, that could not happen because he never filed a claim until 2007. His comment was, "Listen, I never thought that I could get what I got and inasmuch as the VFW was able to do this for him, we could do that also." We informed him that we are good, but not that good!

Greetings Comrades,

Quartermasters, when submitting your audits, please make sure your Post and District number is in the upper right corner of the paper. This makes the filing process much easier for all concerned.

I'd like to commend a number of Quartermasters and trustees and Commanders in this article. The number of returned audits for correction has dropped quite a bit. Thank you comrades. We still, however, have a few that are continuing to have the same errors on the quarterly audits. Comrades, if you are having problems in this area, please contact your District Quartermaster or past Post Quartermaster for assistance. You can also attend one of the classes at the Department Conferences or one in your District, if they have one.

The most common errors on the audits are:

1. Starting balances of the quarter (column 10) do not match the ending balances on the previous quarterly report (column 13). These figures must match.
2. All accounts are not listed, i.e.; Bingo, lottery, keno, savings, lounge, cash on hand and such.
3. Reconciliation of funds balances (box 17) is not being completed.
4. The totals in the net cash balance at the end of the quarter (box 15) **MUST MATCH** the total in the reconciliation of funds balance (box 17).
5. The totals across for column 10 plus

column 11 minus column 12 must match the totals down in column 13.

6. Numerical figures are illegible or the copied form is very dark.

7. Trustee's signatures. All three trustees.

Lastly, we still have a few audits that were returned for correction (through respective District Commanders) and were due in March, 2009, that have not been returned as corrected. This also holds true for audits due in June. Comrades, errors on these uncorrected/unrevised audits can, and will, affect your current audits. Please see what can be done about these, as those incorrect audits can be the reason some audits were returned. All Post inspections have been reviewed and have been returned to the respective District Commanders for dissemination to their Posts. You should be receiving your Post copy (if one was provided) in the near future. The areas of attention on the inspections are highlighted in either blue or red, depending on the importance. DISTRICT 5 REPORT

Comrades,

This article finds us seven months into this command year. A lot has been accomplished in that time, yet much remains to do in the five months remaining. During the last seven months, both my officers and myself have expended a lot of time and energy trying to impress upon each Post the importance and the need to protect their nonprofit status by reporting both their community, as well as their hospital service. On the whole our message has been well received. The great majority of our Posts are doing a great job of reporting their activities, but a few remain. We will be redoubling our efforts to get this message out to these Posts. It is our goal to be reported in all categories across the board by Convention. With a little help from our delinquent Posts this is well within our grasp.

While reporting is important, it is only a first step. One that gives each Post a firm position from which they can reach out beyond to do that which the Veterans of Foreign Wars is now asking. I speak here of those core issues that make us who we are: Military Assistance, Poppies and our Political Action Committee.

Military Assistance needs no explanation. It is simple what we do, why we are here. There are programs at both the department and national levels that do a fine job in this area. Each of our Posts needs to support their efforts. We can best do this by donating to our Military Assistance program. I encourage each Post in our District to consider making a donation. The need here is great and grows greater by the day.

Poppies are another program that needs no explanation. Distributing poppies each year helps to fill the relief funds of our various Posts. I encourage each Post to purchase a minimum of 500 poppies. Most have already done so, but many have not. This is a win-win situation. By purchasing poppies you support those veterans who produce them and by distributing them you fill your relief fund for use in veteran relief at your Post level.

The last program that I would like to

speak of is our Political Action Committee. At first glance there seems to be no benefit for our veterans here, but we need to remember that it is our politicians that eventually enact the laws that affect us all. A strong Political Action Committee helps us in our continuing lobbying of Congress for veteran benefits and rights. We may not like the game of politics, but it is one we need to master if we are to succeed in protecting our veterans' rights. I hope that each Post will support this program with a donation.

Finally, before I let you go, I would like to address the subject of membership. If you know me or have ever met me you know that the last thing I speak of on my way out the door is membership. Membership is everything! Without it all of our programs, all of our veteran support, all our youth programs, all our community service suffers. This organization needs – and must have – a strong and committed membership to accomplish our goals. In the first seven months of this year, our District has made great strides in this area. Today we stand at 94.56 percent, second in the Department. November and December were great months for us. We were able to bring a large number of our unpaid members into the fold for another year, along with recruiting new and reinstated members. Now it seems the January doldrums have set in and our growth has slowed. We need our Commanders, along with their officers, to redouble their efforts to retain our remaining unpaid members as well as recruit. We are in a position this year to achieve our 100% goal and to begin to grow again. This District, along with our Department, has experienced a decline in membership over the last several years. This is the year to stop the slide and to reverse it. You have all done a great job so far this year in this area, but now is not the time to stop. My officers and I are here to help. Rest assured we will be there for the rest of the year, pushing each of you to excel in this area. With a little effort we will accomplish all we have set our sights on.

There is no charge to the VFW for the production of the hand stamp or for the Postal Service's staffing of the temporary station. Additional Loyalty Day materials are available at www.vfwstore.org, under citizenship education.

The VFW Posts and its Ladies Auxiliaries in Michigan have an opportunity for a one-day Pictorial Cancellation by applying to your local post office no later than March 1, 2010. Participating with your Post to hold this event for Loyalty Day on or around Saturday, May 1, 2010, will publicly reaffirm the complete loyalty of the citizens of Michigan to the United States by commemorating this date in U.S. history. This would be a statewide Loyalty Day event.

VA Health Care

- Establish sufficient, predictable and timely VA funding.
- Ensure unique health care and benefits challenges of Iraq and Afghanistan war vets are met, including increased funding for traumatic brain injuries and improved access to care.
- Hire specialized health care providers for women veterans who provide training for gender-specific care, mental health care and military sexual trauma.
- Improve VA outreach so that all veterans – especially female, minority and rural veterans – are aware of the range of health care services and benefits available to them.

VA Benefits and Compensation

- Ensure Congress provides adequate resources to enable VBA to reduce current backlog of disability claims.
- Call on congress to use its vial oversight to ensure true leadership and accountability within VBA.
- Call on VA to determine which disabilities, and level of disability, adversely affect a veteran's quality of life.
- Adjust VA's Schedule for Rating Disability to ensure that veterans are adequately compensated.

Military Quality of Life

- Ensure that active duty, National Guard and Reserve troops receive increased pay, affordable health care and adequate housing and work facilities for themselves and their families.

Seamless Transition

- Encourage seamless transition for vets transferring from DOD to VA, including electronic medical records that travel from duty stations to wherever veterans receive VA health care.
- Improve veterans transition services and benefits, including viable training, employment and education programs to provide meaningful careers.

Military Affairs

- Seek to improve the quality of life for all active duty troops, reservists and their families.
- Provide a military base pay raise to restore full comparability with private sector wages.
- Support efforts to lower the Guard and Reserve retirement pay age from 60 to 55.
- Oppose any TRICARE fee increases.

Veterans Employment

- Urge Congress to immediately address the highest unemployment rates among veterans in recent history by requiring all federal programs to adhere to already existing veterans'

employment and small business laws.

- Solidify Uniformed Service Employment and Re-Employment Rights Act (USERRA) and reverse legal decisions that tend to favor employment.
- Urge the Department of Labor to be more thorough and timely in its USERRA investigations.
- Urge Congress to mandate that all federal agencies fulfill the 3% government-wide procurement goal for service disabled veteran-owned small businesses and require agencies to report their procurement levels and be held accountable if they fail to meet the 3% goal.

Defense and Homeland Security

- Support U.S. troops and their mission to prosecute the war on terrorism around the world.
- Increase defense spending to fund personnel initiatives, troop end-strength requirements and needed weapons programs.
- Halt development and proliferation of nuclear weapons and material.
- Urge the continued development and deployment of a ballistic missile defense system.
- Secure U.S. borders, shorelines and all ports of entry.

POW/MIA

- Archive the fullest possible accounting of all U.S. military personnel missing from all wars.
- Ensure the U.S. government keeps the POW/MIA issue elevated as a national priority.
- Urge the President and Congress fully fund the Joint POW/MIA Accounting Command through a dedicated single line item appropriate in the Defense budget.

National President Attends Veterans Day Events, Presents Donation for Memorial Restoration

Kansas City, MO – Ladies Auxiliary VFW National President Jan Tittle of South Carolina represented the 550,000 members of the Ladies Auxiliary VFW in Washington, D.C., for Veterans Day events.

On Veterans Day morning, President Tittle attended a breakfast at The White House, where she was able to speak with First Lady Michelle Obama and Dr. Jill Biden about their mutual concerns, including active-duty military and their families. "Those who give their lives to the military have unique stresses, and we want to work to make their lives better."

Later that morning in the wind and rain, President Tittle attended services at Arlington National Cemetery with VFW Senior Vice Commander-in-Chief Richard Eubank of California, where they presented a wreath. They were accompanied by VFW and Auxiliary members from Virginia, Maryland and the District of Columbia.

President Tittle's next stop was the Vietnam Veterans Memorial, where she and Senior Vice Commander-in-Chief Eubank presented a wreath on behalf of

all members in honor of the men and women who fought in the Vietnam War.

After the ceremony, President Tittle had the honor of giving a \$10,000 donation to the Vietnam Veterans Memorial Fund (VVMF) for restoration work to be done on The Three Servicemen statue, which is featured on the cover of President Tittle's *National Program Book*. VVMF President and Founder Jan C. Scroggs accepted the donation, and National President Tittle is asking members to consider giving a gift toward restoration efforts in honor, or in memory, of their Vietnam veteran to VVMF. Millions of dollars in renovations are needed for the entire Vietnam Veterans Memorial site, including The Wall, The Three Servicemen statue and surrounding areas. Breaking Big Ground at the Little Post

The gray-bricked building sits atop a hill across from the Shiawassee River in the small mid-Michigan town of Linden (pop. 3,500). It is a picturesque scene complete with a gazebo, working waterwheel and an old 1840's mill and dam. The building has been home to the Price, Crane, Robinson's VFW Post 4642 since 1949. We may be Post 4642, but the Linden community often refers to us as the "little Post."

Linden's Post is truly having a monumental year. They are setting one record after another of historical firsts. In just three months, the Post has had three groundbreaking events. At a regular meeting in November 2009, the Post swore in a third generation Hogan. More than 30 years separate VFW member Woody Hogan from his son, Dennis, and another 28 years separate Hogan from his grandson, Aaron. Woody Hogan served with the Navy in World War II, his son Dennis served with the Army in Vietnam, and his grandson Aaron served with the Army in Iraq. Aaron Hogan, 33, was sworn in before 28 VFW members in a private ceremony, joining his father and grandfather as active members of the Post. Affectionately known as "Hogan's Heroes," Woody, Dennis, and Aaron made history as the 4642's first VFW members representing three generations.

In December 2009, the Post swore in the first female member since it was chartered on December 16, 1945. Marine Sgt. Mary Dunkley, 40, and her husband Richard, also serving as a member of the Army National Guard and attached to the 125th Infantry Brigade in Flint, Michigan, moved to Linden in 2003. Mary enlisted in 1987 and was active until 1993, during which time she was deployed overseas serving in the Gulf War, Desert Storm and Desert Shield. When she arrived in Saudi Arabia in 1990, she was part of the Surveillance Recognition Intelligence Group (SRIG) and the first female to arrive there. Mary has two sons and was honored that she was the first female member of the Post.

On January 14th, 2010, the Post marks another precedent by swearing in the first husband and wife, Robert and Cheryl Stewart of Linden. Cheryl was in the Army from 1984 to 1988 and from 1989 to 1992. She served in Desert Storm from December 1990 through March 1991 in Dhahran, Saudi Arabia, in the 202nd Military Intelligence Battalion as a personnel sergeant and photojournalist. Rob was in the U.S. Army 1983 to 1988, the U.S. Army Reserve February 1993 to February 1994 and then the U.S. Army from February 1994 through

July 2000. In July 2000, he began serving in the U.S. Army National Guard (Active Guard Reserve), retiring from active duty February 2009. Cheryl said "We met in the Army, but after having children we did not want to both be in (the service) at the same time," which explains breaks in their service time. She added "We took turns going to war and being civilians...we lived both sides of the coin."

In the past several months, Linden's Post 4642 has added 10 new members. Total membership is 102...82 Life Members, 6 new transfers, 1 reinstated and 13 annual. This puts the Linden Post at 104%. I say, "hats off to the little Post in Linden, Michigan!" If you are ever in this area, please feel free to visit us. Business meetings are the second Thursday of each month and our social (dinner) meetings are the fourth Thursday of each month. Our door is always open.

Sites during President Tittle's trip included the Taipei Veterans Hospital, where physicians are given housing on site, so as to make care for veterans as accessible as possible. The hospital has also recently

responded to the increase of female veterans by opening a special center for women. The hospital's slogan, posted over the main entrance of the hospital is, "Long Live People, Long Live Generations."

A trip into the mountains brought President Tittle and her daughter, member Jamie Godfrey, to the Ching Jeng Veterans Farm, which is a working sheep and tea farm open to the public. All the proceeds from the farm go to veterans' care. "What this country does for its veterans is amazing," said President Tittle. "They put an incredible amount of thought into how best to serve their veterans and their citizens."

Does America Still Have Heroes?

"We don't have to turn to our history books for heroes. They're all around us. One who sits among you here tonight epitomized that heroism at the end of the longest imprisonment ever inflicted on men of our armed forces. Who will ever forget that night when we waited for television to bring us the scene of that first plane landing at Clark Field in the Philippines bringing our P.O.W.s home? The plane door opened and Jeremiah Denton came slowly down the ramp. He caught sight of our flag, saluted it, said, "God bless America," and then thanked us for bringing him home."

Ronald Reagan made a great statement then, and it still holds truth for us today. We don't have to look in the past to find heroes, because they surround us today. Two of our greatest heroes are our P.O.W.s and our military families. They sacrifice so much and gain so little. They don't make these sacrifices for the recognition and they aren't looking to be labeled as a hero. They do it, selflessly, for the country that they love.

Prisoners of War, also known as P.O.W.s, are told every day that they no longer have control over themselves, yet they continue to sustain their pride and dignity by refusing to give in to their oppressors. I have no doubt that there are days when these men and women want to just give up and die, but they don't. What drives these men and women? What keeps them from giving in? How can a person in such a state of hopelessness show such perseverance and dedication? They hold onto the dream, the dream that one day they will make it home. One day they will stand side by side with fellow Americans and salute their nation's flag. One day they will be free.

Jeremiah Denton is the perfect example of the persevering and uncompromising spirit of the POWs. Mr. Denton spent seven years and seven months in the hands of the Northern Vietnamese. At one point he was told to do an interview that would be good propaganda for the Communists. When asked his position on the war, he answered, "I don't know what is happening now in Vietnam, because the only news sources I have are North Vietnamese, but whatever the position of my government is, I believe in it, support it, and I will support it as long as I live." He silenced the room with this comment. A week later he was given the worst torture treatment that he ever received. It continued all night long and left, even, the Vietnamese guards with tears in their eyes. Jeremiah Denton was finally brought back home, and the first thing that he did was salute his nation's flag.

I cannot properly articulate the heroic deeds of our military without looking at the

driving force behind them: Their families. Parents, spouses, and children are sacrificing time and those special moments in everyday life with their loved ones. Sons are missing their first baseball game with their dads, daughters are missing their shopping trips with their moms, husbands and wives are, for the time being, raising families single-handedly, and moms and dads are separated from their children for the greatest amount of time in their whole lives. They are all sacrificing these things for one cause, so that the freedoms we have in America will remain in America. You cannot tell me this would be an easy feat for just anyone. I think people often overlook the sacrifices made by military families, yet their sacrifices are so great. Sometimes their sacrifices are the greatest, because sometimes, soldiers don't make it home. Sometimes sons never get that first baseball game, daughters never do go shopping, husbands and wives are left to raise their children on their own, and sometimes moms and dads are forced to give up the dream of having their child walk through their front door. Sometimes lives are taken far before they should've been, and the wake of sorrow they leave behind them never ends. Therefore they give the greatest sacrifice, because I can guarantee you, there isn't one mother or father who doesn't wish they could've taken the place of their child.

If you don't believe me that families take the worst hits in this war, just ask Amanda Jordan, wife of the late Marine Sgt. Phillip Jordan. Amanda not only had to deal with losing her husband, she had to explain it to their six year old son, Tyler. This six year old boy walked around for a week wearing his 6-foot-3-inch father's camouflage shirt, not speaking to anyone. She desperately tried to explain that God needed his daddy in heaven, only to hear him say, "Well, I needed him, too." Tyler, and many other children like him, will grow up without a father, and their mothers will spend the rest of their lives trying to explain why. But at the end of the day they will still stand when their nation's flag is raised, because they know the price it took to have the freedom to raise it.

Does America still have heroes? Are you kidding me? Look at a child in the eye and tell him that his father, who is a POW over in Iraq, is not a hero. Look at a soldier in the eye and tell him that his mother is not a hero for supporting him in defending his country. I'd bet my life on it that you can't. These men and women are sacrificing years, if not all of their lives to making sure America remains a free country. They are giving everything so that you and I can stand and salute our nation's flag. They love America and show it in their everyday lives. I believe America does still have heroes, and they are my reason why.

Three Teachers Selected for National Awards

Each year for the past eleven years, three exceptional teachers have been recognized by the Veterans of Foreign Wars (VFW) for their outstanding commitment to teach Americanism and patriotism to their students.

The VFW National Citizenship Education Teacher Award recipients are selected from entries submitted by local VFW Posts in every state, District of Columbia and overseas. Patricia Mazure, a K-5 teacher at William C. Taylor Elementary in Trenton, Michigan, has been named the winner at the elementary school level. At the middle school level, Mark D. Leet, a teacher at Simons Middle School in Flemingsburg,

Kentucky, was named the winner. William V. Melega, a teacher at Chapel Hill High School in Chapel Hill, North Carolina, was selected at the high school level.

Each teacher receives the VFW Past Commander-in-Chief John Smart award of \$1,000 for their professional development and another \$1,000 goes to their school. In addition, all three teachers receive an all-expenses-paid trip to Washington, D.C., where the awards will be presented during the Veterans of Foreign Wars National Legislative Conference, March 6-10, at the Hyatt Regency Crystal City.

Steve Van Buskirk, director of VFW Programs, acknowledged, "Honoring America's teachers has been a tradition for nearly 100 years. Next to parents, they hold the key to raising up young civic-minded patriots who will perpetuate the values that have made this nation great."

65th Anniversary of The Battle of the Bulge: A Proclamation by the President

In December 1944, in a dense forest in Belgium, a brave band of American soldiers who were surrounded, poorly supplied and surviving in brutally cold conditions, took the brunt of a furious German assault. Their valor defined not just the beginning of the end of a World War, but also one of the greatest generations of Americans. Like patriots before them, they stood resolute, confident in their training, and determined to preserve those enduring American ideals of freedom and justice. On the 65th Anniversary of the Battle of the Bulge, a grateful nation remembers the fallen who gave their lives in that critical battle, and we pay tribute to the heroes whose indomitable strength led to victory in World War II.

When asked about the Battle of the Bulge, British Prime Minister Sir Winston Churchill remarked, "This is undoubtedly the greatest American battle of the war and will, I believe, be regarded as an ever-famous American victory." Confronting not just the advancing German Army, but the elements, American service members withstood the assault and eventually repelled the Nazi forces, but at tremendous cost in lives

and wounded soldiers.

On this anniversary, we reflect on the enduring commitment of our Armed Forces in defending our liberty, as inspiring today as it was in 1944. The discipline and courage displayed in the Battle of the Bulge continues in Iraq, Afghanistan, and wherever our men and women in uniform are serving. They represent the best of our nation, and we are eternally grateful for their service and sacrifice.

NOW, THEREFORE, I, BARACK OBAMA, President of the United States of America, by virtue of the authority vested in me by the Constitution and the laws of the United States, do hereby proclaim Wednesday, December 16, 2009, as the 65th Anniversary of the Battle of the Bulge. I encourage all Americans to observe this solemn day of remembrance with appropriate ceremonies and activities.

IN WITNESS WHEREOF, I have hereunto set my hand this fifteenth day of December, in the year of our Lord two thousand nine, and of the Independence of the United States of America the two hundred and thirty-fourth.

Senate Moves Vet Bills

The Senate VA Committee marked up two VFW-supported bills yesterday. Draft legislation introduced by Committee Chairman Daniel Akaka (D-HI) would authorize funding for an advisory board to make recommendations on care for service members and their families affected by environmental hazards at Camp Lejeune, NC, and the Atsugi Naval Air Facility in Japan. Ranking Member Richard Burr (R-NC) offered an amendment that would authorize VA to provide hospital care, medical services and nursing home care to veterans who became ill from contaminated water at Camp Lejeune. Committee members defeated the amendment, suggesting that DoD should provide the care as it falls under their jurisdiction.

Chairman Akaka promised to meet with Armed Services Committee members to bring about closure for the families of those who are affected.

The other bill – S. 1237, The Homeless Women Veterans and Homeless Veterans with Children Act – would authorize \$10 million annually for FY 2011-2014 to provide jobs, training and childcare for homeless women veterans and homeless veterans with children. Several amendments offered would expand the grant program to male veterans with children, and allow 5% of the funding to be set aside for facilities in rural areas.

Finding Your Next Job

The following article appears in VFW magazine's special edition booklet, *To War and Back*.

Even in a climate of high young vet unemployment, jobs still are available for returning veterans. Programs online and around the country can help. Employment opportunities for Iraq and Afghanistan vets have fluctuated dramatically.

As of October 2009, the unemployment rate for post-Sept. 11, 2001, vets stood at 11.6%, according to the Labor Department's Bureau of Labor Statistics.

Widely varying unemployment rates may show that these individuals are having difficulty transitioning to civilian jobs following Iraq or Afghanistan deployments. "If you served in the military, you're disconnected from the civilian workforce, you don't have contacts that a civilian person has," Justin Brown, VFW legislative associate, told *USA Today*.

Regardless of the cause of the documented high unemployment rates, federal and private programs exist to help vets find jobs after returning from war.

• **VetJobs** averages more job postings than any other military- or intelligence-related job board. An employment assistance section includes information on how to organize a job search, write a resume, interview and identify a potential employer. Its monthly newsletter for veterans, the *Veteran Eagle*, has information about employment and the job market. VFW partners with this job board.

• **American Corporate Partners** helps vets transition from the military to the workforce through career counseling and networking with corporate professionals. Some 300 mentors are available from Campbell Soup Company, General Electric, Home Depot, Morgan Stanley, PepsiCo and Verizon. Iraq and Afghanistan veterans – especially those who have been wounded – take precedence for selection in the program.

• **Entrepreneurship Boot camp for Veterans With Disabilities** provides entrepreneurship training and small business management to disabled Iraq and Afghanistan vets. The Whitman School of Management at Syracuse University, UCLA Anderson School of Management, Florida State University's College of Business and Mays Business School at Texas A&M offer these free

nine-day residency programs.

• **Texas Veterans Leadership Program** strives to match recently discharged vets with employers and also offers advice on VA benefits.

• **VA's Veterans Employment Coordination Service** helps veterans – especially wounded vets – who are interested in working for VA. Services include employment counseling, identifying transferable skills, a career assessment, resume and job search assistance, and direct job placement assistance.

• **Small Business Administration's Veterans Business Outreach Program** provides entrepreneurial development services including business training, counseling and mentoring, and referrals for eligible veterans who own or are considering starting a small business. Four organizations participate in this cooperative agreement and serve as Veterans Business Outreach Centers.

• **Hire Vets First**, coordinated by the Department of Labor's Veterans Employment and Training Service, offers links to online job search engines and resume assistance. Its nearly 2,000 One-Stop Career Centers assist with job search, resume writing, job placement, interviewing skills, career counseling, labor market information and financial aid information.

• **The Little Caesars Veterans Program** offers a \$5,000 reduction of the franchising fee, financing benefits and a \$5,000 credit on the equipment order for the veterans opening their first store in this chain. Service-disabled veterans are eligible for a total benefit of up to \$68,000.

For reservists called to active duty, job protection is afforded under the 1994 *Uniformed Services Employment and Reemployment Rights Act*. The Employer Support of the Guard and Reserve agency exists to provide assistance in this regard.

In November 2009, an executive order created the Council on Veterans Employment, charged with increasing the number of vets hired by the federal government. Each of 24 executive branch agencies must form a veterans employment program. The Office of Personnel Management is tasked with developing a strategic plan for veterans' recruitment and employment.

Advances for Women Veterans Move Forward

The Veterans of Foreign Wars of the United States is applauding two key developments for women veterans. On November 19, the Senate passed bill S. 1963, The Caregiver and Veterans Omnibus Health Services Act of 2009 (98-0).

"This is major progress toward more fully acknowledging the vital military contributions of women during war and peace. We're confident the provisions for women's health care will make it to the President's desk quickly," said Eric A. Hilleman, Director, VFW National Legislative Service.

S. 1963 includes six VFW-supported bills. Key provisions include:

- Studies on access to care for female veterans
- Improvements in training and care for military sexual trauma
- Providing child care services for veterans seeking treatment at VA
- Expanding services to veterans in rural areas
- Providing caregiver support, counseling

and a stipend for family members taking care of veterans

- Allowing catastrophically disabled veterans emergency care outside VA
- Enhanced programs aimed at reducing homelessness among veterans

S. 1963 was previously stalled by Senator Tom Coburn (R-OK) due to costs.

In another major development, Secretary of Veterans Affairs Eric K. Shinseki announced the Department of Veterans Affairs (VA) is launching a comprehensive study of women veterans who served during the Vietnam War.

The research will explore the effects of their military service on their mental and physical health. The study is considered the most comprehensive examination of women Vietnam veterans to date.

The VA estimates there are approximately 1.8 million women veterans in the United States. Nearly 15% of service members on active duty are female, with numbers on the rise.





VA Aggressively Working Claims Backlog

WASHINGTON, January 4, 2010 – The National Commander of the Veterans of Foreign Wars of the U.S. said the most important takeaway from last night's *60 Minutes* piece on the Department of Veterans Affairs was that the VA is aggressively working to overcome a claims backlog that is currently delaying benefits payments to hundreds of thousands of disabled military veterans.

"The backlog is something the VFW is very concerned about," said Thomas J. Tradewell Sr., a combat-wounded Vietnam veteran from Sussex, Wisconsin.

"We understand the frustration that veterans and their families experience from delayed, rejected or improperly adjudicated claims, but we also know there are no quick fixes," he said. "That's why the VFW will continue to work with VA leadership and Congress to find a permanent solution, because we know the backlog will only continue to rise as the veterans' population ages, as more become eligible from the wars in Afghanistan and Iraq and elsewhere, as presumptive illnesses and programs are expanded, and as more veterans learn about the government programs and benefits available to them."

The VFW has, for a number of years, lobbied the Administration and Congress for additional funding and new oversight to address the claims problem. In response, the VA has added 4,200 new employees to

compensation and pension claims processing over the past three years. They are working diligently to develop new information technology programs that will assist in the claims process system, and working jointly with the Defense Department to create an electronic medical and service record capability to ease a veteran's transition from DoD to VA care.

As VA continues to expand their outreach efforts to eligible veterans, they also recommend claimants seek the assistance of trained service officers that veterans' service organizations like the VFW provide at no cost to all eligible veterans.

VFW-trained service officers last year helped almost 95,000 veterans to recoup more than \$1.2 billion in earned compensation and pension. The VFW also served almost 10,000 more at military installations around the country through a program called Benefits Delivery at Discharge, which helps personnel complete VA paperwork prior to their separation or retirement from the military.

"The VFW is the VA's strongest ally in Congress and sometimes its loudest critic, but we recognize that only by working together will the claims backlog problem be solved," said Tradewell. "We are a willing partner in helping to find a permanent solution so that our government can better care for those who have worn the uniform."

Vietnam MIAs Identified

The Defense POW/Missing Personnel Office announced the identification of Army Spec. Lawrence L. Aldrich of Fort Worth, Texas. On May 6, 1968, Aldrich was on a search-and-clear mission in South Vietnam's Binh Dinh Province. He was last seen engaged in a battle manning a M-60 machine gun position with two others. An air strike was called in, but one of the bombs inadvertently landed on Aldrich's position, killing all three. Their unit recovered remains of the other two, but Aldrich could not be found. In 1992, a local citizen took a joint U.S.-Vietnamese investigation team to a location where he thought the remains were buried, but an excavation revealed nothing. In 2006, Vietnamese officials unilaterally investigating the case interviewed two other villagers, who recalled finding the body of an American and burying it where it lay. A second joint investigation recommended another excavation, which occurred in March 2009. That excavation unearthed human remains and other non-biological evidence, which led to Aldrich's identification. He was buried January 31 in his hometown of Fort Worth.

The remains of Air Force Maj. Russell C. Goodman of Salt Lake City have been identified and will be returned home to his family for burial in Alaska. He is to be honored this week at Nellis AFB, NV, home of the Air

Force's Thunderbirds aerial demonstration team, because he was assigned to the team while flying with the Navy on an exchange program at the time of loss. On February 20, 1967, Goodman and Navy Lt. Gary L. Thornton took off from the *USS Enterprise* in an F-4B Phantom on a bombing mission against a railroad yard in Thanh Hoa Province, North Vietnam. They were struck by enemy antiaircraft fire and their plane exploded. Thornton was able to eject at minimum altitude, but Goodman did not. Thornton was held captive until his release in 1973 during Operation Homecoming. Between October 1993 and March 2008, joint U.S.-Vietnamese teams, led by the Joint POW/MIA Accounting Command, investigated the crash site twice and conducted two excavations, recovering human remains and pilot equipment, as well as aircraft debris that correlated with an F-4B. Along with other forensic identification tools and circumstantial evidence, scientists from JPAC and the Armed Forces DNA Identification Laboratory used mitochondrial DNA – which matched two of his maternal relatives – to identify Goodman's remains.
