## SENIOR VICE COMMANDER

The year is coming to a close and all election reports should be in to National and Department. Please remember you may only hold one elected position at the Post. Also delegate fees for National and Department Convention should have been sent in; you must do this, even if you do not send somebody to National and Department Convention. If you think your Post is All-State, please get the paperwork into Larry Thayer by the deadline.

Membership, comrades, is down about 2,000 members from last year; we still have until the end of June to get this to 100%. We cannot keep losing members at this rate without replacing them, and we must do more to keep the members that we have. At the end of last year the Department of Michigan Membership stood at 49,809 members. Now let's break that down by age: 12.195% is below the age of 54; 19.181% is 55 to 65 years of age; 20.237% is 66 to 70 year of age; 5.971% is 71 to 75 years of age; 6.553% is 76 to 80 years of age; and 35.042% are 81 and over. We need to all be working on this before it's too late.

## STATE SERVICE OFFICER

### Advocating for Others

One of the new and innovative ways for the Department of Veterans Affairs to help reduce the backlog in claims is through the Fully Developed Claims (FDC) Program. It is the fastest way of getting one's compensation or pension claim processed. Participation in the FDC Program allows for faster claims processing, while preserving great quality of service and your right to appeal a decision. The FDC Program is unique because we know exactly what evidence is needed to substantiate an eligible claim when you apply, without having to wait for further instructions from the VA.

VA has shortened application forms to reduce paperwork and established priority channels to process your FDC claim. This means the VA is able to process these claims far more quickly than claims going through the traditional process.

In addition, Disability Benefits Questionnaires (DBQ) help support the Fully Developed Claims Program. DBQ's are valuable for claims processing because they provide medical information that is directly relevant to determining a disability rating. When submitted with a Fully Developed Claim, DBQ's ensure the VA's ratings specialists have precisely the information they need to start processing the claim.

With DBQs, veterans now have more

control over the disability claims process. Veterans have the option of visiting a private health care provider instead of a VA facility to complete their disability evaluation form.

Veterans can have their providers fill out any of the more than 70 DBQs that are appropriate for their conditions and submit them to us for preparation and presentation to the VA.

Caution! Once the claim has been submitted as a FDC, no other information can be submitted. This means that if a veteran submits anything after the FDC has been submitted, the claim will be reverted to the standard method. Of course, we all know how long that takes. By participating in the FDC Program, the veteran will send us the required evidence with his/her claim and certify that no further evidence will be forthcoming. By doing this, one dramatically reduces the processing time of a claim process.

It is our intent to submit as many FDCs as possible because it is a "win win" for everyone involved in the claims process.

## Success Story

On November 12, 2012 our advocate met with a "boots on the ground" soldier in Vietnam who served in the United States Army from March 1966 to March 1969 and worked as a vehicle mechanic.

The veteran was originally receiving a 10% service-connected disability and was basically surviving off his Social Security Retirement. Unfortunately, he had no other sources of income and neither did his wife who was with him the day that would change his life forever.

After an extensive review and discussion with the veteran and his wife, it became apparent that a friendship had been forged. In fact, our advocate took ownership of the veteran's case and found that listening to a veteran's concerns and issues was paramount to the ultimate outcome of the case. The veteran developed a trust in our staff member that only comes from a heartfelt sincerity on behalf of our advocate.

On February 11, 2013, the veteran was awarded an increase in his service-connected condition from 10% to 100%. In addition, he met the criteria of Liberalizing Legislation pursuant to 38 CFR 3.114, which awarded him a retro payment up to one year because of a change in the law.

After all the dust settled, the veteran received a retro payment of \$65,128 tax free and regular monthly payments from the VA at \$2,973 per month.

The veteran's income went from \$16,500.00 a year to \$52,000 in just a few months. Needless to say that his visit to the VA Medical Center, a day after Veterans Day in 2012, was a life-altering event, especially for this veteran and his spouse who are now living a much more fruitful life. Finally, the veteran is receiving the care he deserves after his tour in Vietnam and exposure to Herbicide, most commonly referred to as Agent Orange.

The veteran came by the VA Medical Center to see our advocate in person a few weeks after he received his retro money and he looked like a new man. He handed our staff member a card thanking him "for all his help with the claim and explaining things to him when he didn't understand the many letters he received from the VA". The "thank you" card went on to say, "it was nice to have someone who was really willing to help".

The bottom line is that the "VFW Service Office here in Michigan is in the business of changing lives" and that's what our advocates do every day!

## LEGISLATIVE DIRECTOR

As many of you are aware, I have been encouraging all Posts/Districts to allow members to bring children to their meetings. This may be the only way that a comrade is able to attend the meeting and we do not want to turn away members. I spoke with National (Kevin Jones) about allowing children to attend meetings, and with the help of Department Adjutant Stu Billey, they instructed us to look at Sec 203 of the National Bylaws, which states:

**Guests.** With the approval of the Post Commander/Committee Chairman, any visiting member or guest may attend a Post/Committee meeting. Such visiting member or guest shall have no voice unless recognized by the Post Commander/Committee Chairman, and shall have no voting privileges. I would like to emphasize that the main reason for this much-needed change is to allow our young children to attend. If a GUEST would like to address the body, then the Bible should be closed; in the case of our young children, it can remain open. This means that anyone, with permission from the Post Commander/Committee Chairman, may attend the meeting. Members that have children can still attend the meeting with their children. After all, we are a family organization.

**Protect Combat Medals – Support Passage of H.R. 833 and S. 470.** The Pentagon recently announced the creation of “The Distinguished Warfare Medal”, which would recognize service members with special training and capabilities that directly impact military operations, regardless of distance from the battlefield. The newly created medal would outrank the Bronze Star and Purple Heart. The VFW immediately came out in opposition of the placement of the medal. This medal would leapfrog more than five dozen combat medals and ribbons – to include valor and combat injury awards. Contact your representatives and senators today and urge them to support H.R. 833 and S. 470. Tell them that medals that are earned for valor or wounds in combat must outrank any new medals earned in the rear for combat support.

**The Military Tuition Assistance** amendments passed both the House and Senate as part of the Continuing Resolution bill (H.R. 933) that will now fund the federal government moving forward. Thanks to all of you – *our advocates*.

## VOD/PATRIOT'S PEN

The VOD, Patriot's Pen, Teacher of the Year Committee would like to thank the comrades and sisters for their hard work in making the program a great success. A special thanks to all the Post and District Chairmen for all your help in making the deadlines and having all the forms completed.

An update on our students: VOD winner Catherine C. Seibert, sponsored by Post 2777, District 10, placed twenty-second place out of fifty-four students and received a \$2,000 scholarship at the National level. Our Patriot's Pen winner, Emilia R. Gnida, sponsored by Post 6950, District 11, came in fifth place on the National level and received a \$2,500.00 award. Congratulations to both of our outstanding students.



**CBS apologizes:** The CBS reality show *Amazing Race*, “Apologizes for parts of an episode that were filmed in Vietnam, were insensitive to a group that is very important to us: our nation's veterans. We want to apologize to veterans – particularly those who served in Vietnam – as well as their families and any viewers who were offended by the broadcast. All of us here have the most profound respect for the men and women who fight for our country.”

**Healthcare for Iraq/Afghan Veterans:** Iraq and Afghanistan veterans discharged from active duty on or after January 28, 2003, may be eligible for five years of medical care. The Department of Veterans Affairs is trying to reach out to eligible veterans who served “in a theater of combat operations” to let them know that they may be eligible for complete health care coverage for five years post service. To determine eligibility, visit the Veterans Health Administration website at: [http://www.va.gov/healthbenefits/resources/eligibility\\_check.asp](http://www.va.gov/healthbenefits/resources/eligibility_check.asp). The VHA website provides comprehensive health benefits and includes a link to their fully developed Veterans Health Benefits Guide. **DOD to End Tricare Prime for 172,000:** Starting Oct. 1, the Pentagon will eliminate Tricare Prime for some 172,000 military retirees and their eligible family members, forcing them to either enroll in the more costly Tricare Standard, Extra programs or exit altogether. Why? Because they reside 40 miles or more from a military treatment facility. The VFW views the change as a further lessening of earned benefits, especially since Tricare Standard and Extra have more out-of-pocket expenses, which could influence personal healthcare decisions. 

Bylaws was published in the *MOV* before the Convention last year. The vote was made and passed on the Convention floor. Please inquire into all of the changes that are being made throughout the Department. Remember, you do not get a vote if you do not attend the Convention.

With new members taking offices, please familiarize yourself with the National, Department, District and Post Bylaws. Not only will it make us better-informed members, but it will help to eliminate the, "that's the way it's always been done," mentality. Some of the sections to note are: Sec. 109, which deals with appeal rights. It states that any aggrieved member may submit a written appeal to the next higher authority using

the following chain of command: 1. Post and/or Post Commander; 2. District Commander; 3. Department Commander; 4. Commander-in-Chief; 5. National Council of Administration. Sec. 218 gives the list of the duties for the Post officers. Sec. 1004 mandates the order of business for a Post meeting. A quick review of the current edition of the National Bylaws and Manual of Procedure will help ensure that not only Post meetings, but also the Posts themselves, are run smoother and more efficient.

If anyone has any questions about the VFW, the Bylaws or procedures, please contact the Department Headquarters. We will be more than happy to help in any way possible.

**Grand Rapids Home for Veterans and D.J. Jacobetti Home for Veterans in Marquette**



Project Start has arrived for the long awaited canopy that will cantilever out from the main building directly in front of the administration offices. Commencement date was given on 29 March 2013 for the actual construction to begin – the Contractor has 212 days to complete the Project, which is 26 October 2013. The contractor has given the State of Michigan 1 August 2013 for his targeted completion date. The new canopy is currently being built in Kansas City, Missouri and will actually be the last piece of the puzzle to be installed. The main entrance to the Home will sport a completely new look with a double entrance/exit electronic door opening with a wider opening to easily fit wide wheelchairs and gurneys for the emergency equipment. The driveway load/unload area will be heated (snow melt) along with the sidewalk area for our residents in wheelchairs to get around in the winter weather. This has been a long 18-month battle to make this project a reality! Please use the temporary entrance on the south end of the Mann building where every area will be

Sawyer Air Force Base in the Gwinn area. This is in the primary stages of committee meetings!

The VFW Ladies Auxiliary Bylaws (2012 Bylaws Sec.810A) directs us to have a committee of five members (including the Treasurer) to perform the duties of the membership program. This committee is very important, so that the responsibility for maintaining and growing your Auxiliary's membership does not fall on just one person. The committee can work together to plan your dues mailings (1st done by July 31st), plan public recruiting events (1st done by August 31st), create a display in your Post Home and then follow up with phone calls and personal contacts to get all annual members paid on time. The committee shall report their progress at each monthly meeting until 100% has been achieved. Districts should also have this committee work with each Auxiliary and help them succeed. The first District to reach 100% will earn \$100!

The concept is: one program that all Auxiliaries in the entire District can participate in and pos-

To participate, each Auxiliary is being asked to sponsor a table (8 tickets). Tickets are \$25 per person – no tickets sold at the door. So what happens to the other \$20 from the ticket sale you ask? This money will be used to pay for the expenses of the program: food, tea, tableware, goodie bags, speaker gifts, etc. Everything and anything that will make this an extraordinary program! **Post 4499 Manistee, Michigan Investigate the Israeli Attack on the USS Liberty**

WHEREAS, on June 8, 1967, the *USS Liberty*, while operating in international waters in the eastern Mediterranean, was the target of an attack by Israel war planes and torpedo boats; and

WHEREAS, this attack killed 34 members of the *USS Liberty's* crew and wounded 171 other United States personnel on board in addition to causing extensive damage to the ship; and

WHEREAS, the crew was threatened with prison if they spoke of the attack, and previous investigations were manipulated and controlled, and many new witnesses have come forward; and

WHEREAS, the Veterans of Foreign Wars passed a resolution on

August 17, 2009 supporting an investigation of the attack on the *USS Liberty* and the United States Congress refuses to

address this resolution; and

WHEREAS, the men of the *USS Liberty* have filed a war crime report on June 8, 2005 as per Department of Defense Directive #5810.01B with the Secretary of the Army; and

WHEREAS, the report has been ignored and has languished there with several Secretaries of the Army; and

WHEREAS, the sailors and Marines and their families should have closure of this tragic attack and its aftermath; therefore

BE IT RESOLVED, by the Veterans of Foreign Wars of the United States, that we call upon Congress to immediately investigate the attack on the *USS Liberty* that was perpetrated by the armed forces of the State of Israel on June 8, 1967, in order to determine the truth behind the attack.

**Department of Michigan Bylaw Amendments**

**Amendment MI-1** – Amend the Department of Michigan's Bylaws by including the title “PURPOSE” to Article I and the title “ELIGIBILITY” to Articles III.

**Amendment MI-2** – Amend the Department of Michigan's Bylaws Article I by replacing “three (3)” with “230102” after the word Section.

**Amendment MI-3** – Amend the Department of Michigan's Bylaws Article II, Section 3 by inserting “48906” at the end of the Section.

**Amendment MI-4** – Amend the Department of Michigan's Bylaws Article IV, Section 1 by adding “and VII” after “II”.

**Amendment MI-5** – Amend the Department of Michigan's Bylaws Article IV by eliminating Sections 2 and 4. The remaining section numbers of this Article shall be adjusted accordingly. All remaining Articles of the Bylaws that make reference to this Article shall be adjusted accordingly.

**Amendment MI-6** – Amend the Department of Michigan's Bylaws Article V, Section 1 by replacing “201” with “301”.

**Amendment MI-7** – Amend the Department of Michigan's Bylaws Article VI Districts, Section 3 by adding the words “Redistricting Committee:” after “Section 3.” And moving paragraph (A) to the next line.

**Amendment MI-8** – Amend the Department of Michigan's Bylaws Article VI, Section 3(d), by replacing XVI with XVIII.

**Amendment MI-9** – Amend the Department of Michigan's Bylaws Article VI, by eliminating Section 4 in its entirety and changing Section 5 to 4.

**Amendment MI-10** – Amend the Department of Michigan's Bylaws Article VII, Section 3(A) by adding “VFW National Home for Children” to the list of extending committees.

**Amendment MI-11** – Amend the Department of Michigan's Bylaws Article VII, Section 3(C) by replacing it in its entirety with, “Each committee shall make a report of its activities to the Department Convention.”

**Amendment MI-12** – Amend the Department of Michigan's Bylaws Article VII, Section 5 by eliminating everything following the first sentence to include paragraphs B and C as well as the distinc-

tion of paragraph “A”.

**Amendment MI-13** – Amend the Department of Michigan's Bylaws Article VIII, Section 9 by adding, “except for the State Commander and State Quartermaster who, by virtue of their office, are members of all committees,” at the end of the section.

**Amendment MI-14** – Amend the Department of Michigan's Bylaws Article X Section 1 by deleting, “but not before the requirements of Article VI, Section 4 of these Bylaws have been fulfilled.”

**Amendment MI-15** – Amend the Department of Michigan's Bylaws Article X, Section 3 by deleting, “Starting with the year 1966 and each year thereafter,”

**Amendment MI-16** – Amend the Department of Michigan's Bylaws Article XI Steering Committee, Section 1, by deleting the entire section and adding the following:

“Starting with the 2014 Department Convention, the delegates of the Big Ten Steering Committee shall be composed of the State Commander, State Senior Vice Commander, State Junior Vice Commander, immediate Past State Commander, plus two (2) delegates, elected by the delegates assembles, for a two (2) year term. At the Convention following the end of the delegates' terms, two (2) delegates shall be elected for two (2) year terms.”

**Amendment MI-17** – Amend the Department of Michigan's Bylaws Article VII by inserting the following:

Section 7. All contracts that are deemed to be of a routine nature by the State Commander must first be approved by the State commander, State Senior Vice Commander, and State Junior Vice Commander prior to entering into the contract. All contracts that are deemed to not be of a routine nature by the State Commander must have the approval of the Department Council of Administration prior to entering into the contract.

**Camp Trotter Bylaw Amendments:**

**Amendment CT-1** – Amend Article VI, Section 1, paragraph C by keeping the first sentence and omitting the remaining paragraph and adding the following:

“Annually, on July 1, all monies received as Life Membership fees shall be distributed in equal parts to the “Life Membership Fund” (Long Term Investment Account) and to the “VFW Camp Trotter for Children general fund”.

### 3-Digit Lottery Ticket Fundraiser

I have taken the task of distributing the Department Fundraiser lottery tickets. We need the help of the Posts to distribute these tickets. For the past few months, I have sent two tickets to Posts around the Department. Each ticket costs \$10. We are asking that the tickets be offered to your members to purchase. Alternatively, Posts (after a motion is made and passed by the members at a Post meeting) may purchase the tickets using money from the general fund. If those numbers are drawn, the winnings would be paid back into the Post's general fund. This is a way for Posts to help increase their accounts.

The Department has made a list of the amount of payouts that must be made each month for the entire year versus the amount that is taken in. We estimate that if each ticket is purchased, the Depart-

ment will raise between \$50,000 and \$55,000, depending on postage. To put that in perspective, the amount of money raised by the Department for the \$3 increase to the Department per capita has generated less than \$20,000 since it took effect on October 1. Last year, it would have only generated \$41,994 in extra revenue for the entire year.

If Post members help purchase these tickets, we would be able to continue to support the programs that help our veterans and their families without the worry of increased dues. John E. Hamilton was elected Commander-in-Chief of the Veterans of Foreign Wars on July 25, 2012 at the VFW's 113th National Convention, held in Reno, Nevada.

Mr. Hamilton served in the U.S. Marine Corps from 1968-1970, including a tour in Vietnam. His decorations include the Purple Heart and two Gold stars, Combat Action Ribbon, National Defense Service Medal, Vietnam Service Medal with two Bronze Stars, Republic of Vietnam Meritorious Unit Citation Gallantry Cross Color, Republic of Vietnam Unit Citation Civil Actions Color (First Class) and the Republic of Vietnam Campaign Medal.

He joined the VFW in 1974 at Post 7909 in Jacksonville, Florida, where he maintains his Legacy Life (Gold Level) membership. He has served the VFW in many leadership positions, including the National Council of Adminis-

tration from 1989-1991, and as State Commander from 1987-1988. He served on the board of the VFW National Home from 2002-2008 and as its president from 2004-2005. He also served as Supreme Commander of the Military Order of the Cootie from 1992-1993.

Mr. Hamilton graduated with honors from Georgia Military Academy in 1967. He worked as a professional wrestler throughout the United States and the world for 15 years as Johnny Montana (also known as "Dr. Death"), along with other names and identities.

Mr. Hamilton was named Florida's Young Veteran of the Year in 1981. He has been honored by Presidents Jimmy Carter and George H. W. Bush for his outstanding community service and leadership.

Mr. Hamilton is a member of the Military Order of the Cootie, Military Order of the Purple Heart, Disabled American Veterans, The American Legion and the Semper Fidelis Society.

He was a longtime resident of Jacksonville, Florida and currently resides in St. Augustine, Florida.

### Fallen Soldiers March

Back in 2004, 1st Sergeant Jim Williams organized Tennessee's first Fallen Soldier March in Lebanon. 1st Sgt. (then Sgt. 1st Class) Williams had recently returned from a year long deployment to Iraq with the 168th Military Police Battalion and wanted to honor not only the Tennessee National Guard Soldiers who died in the War on Terror, but all Tennesseans who made the ultimate sacrifice for their state and nation.



## Charlotte Maple City VFW Post 2406 and Auxiliaries Honor WWII Veteran for Service and Sacrifice

On February 16, 2013 the VFW Post 2406 and its Auxiliaries honored WWII Veteran and Ex-Prisoner of War, Harry Bell, with a plaque of recognition. He was also presented Certificates of Appreciation from the State of Michigan signed by Governor Rick Snyder and the Department of the Army.

Harry was honored for his military service and sacrifices that he made during WWII as a waist gunner on a B-17 Bomber, named Millie K. He was a member of the 388th Bomb Group, 560th Bomb Squadron, 8th Air Force. On September 28, 1944 on his 6th bombing mission, his B-17 was hit by flak and all crewmembers successfully bailed out and were captured by the Germans. They were imprisoned in Stalag Luft 4, Gross Tychow, Poland.

After several months of imprisonment at Stalag Luft 4 and as the Russians advanced on this camp, the prisoners were forced on a road march as they were to be relocated to another prisoner of war camp in Hamburg, Germany. They marched over 600 miles in 87 never-to-be-forgotten days. After 8 months being held as a Prisoner of War, he was liberated by allied troops on May 2, 1945. Of those men who started on the march about 1,500 perished from disease, starvation or at the hands of the German guards while attempting to escape.

Harry, who will celebrate his 95th Birthday in July, is a member of VFW Post 2406 and was very humbled by all the recognition and words of appreciation that was extended by all guests in attendance.

## VFW Applauds House Effort to Fund VA in Advance

### The VFW urges swift passage of this much needed bill

February 27, 2013 – The Veterans of Foreign Wars of the U.S., the nation's largest organization of combat veterans, is applauding yesterday's announcement from House Veterans Affairs Committee leadership to fully fund the Department of Veterans Affairs one year in advance.

House VA Committee Chairman Jeff Miller, R-FL, and Ranking Member Mike Michaud, D-Maine, introduced the "Putting Veterans Funding First Act of 2013," or H.R. 813, which would require Congress to fully fund VA's discretionary budget one year ahead of schedule. The measure would ensure that all VA services would have timely and predictable funding at a time of fiscal uncertainty for the nation.

"The VFW applauds Chairman Miller and Ranking Member Michaud for coming together and recognizing that our veterans deserve timely and predictable care and benefits," said VFW National

Commander John Hamilton, a combat wounded Marine Corps rifleman in Vietnam. "Regardless of the difficult fiscal decisions our country may need to make, we can never abandon our responsibility to care for the men and women who have borne the battle."

VA health care, which accounts for nearly 86 percent of the total VA budget, is already funded one year in advance, thanks to VFW's strong advocacy of the Veterans Health Care Budget Reform and Transparency Act of 2009. Advance appropriations for VA health care has allowed VA to deliver consistent care and properly plan for future needs. The goal of H.R. 813 is to allow all of VA to similarly plan for the future by investing in areas like information technology, claims processing and construction.

The VFW urges swift passage of this much needed bill.

## VFW Calls Out TIME Columnist

### VFW outraged that a TIME magazine columnist has called for the resignation of VA Secretary Eric Shinseki

March 15, 2013, WASHINGTON – The National Commander of the nation's largest war veterans organization is outraged that a *TIME* magazine columnist has called for the resignation of Veterans Affairs Secretary Eric Shinseki.

"Freedom of the press isn't a license for Joe Klein to twist reality about someone who has volunteered virtually his entire life to serve his country," said John E. Hamilton, who leads the 2 million-member Veterans of Foreign Wars of the U.S. and its Auxiliaries. Klein's column, entitled "Ten Years After: A National Disgrace," is posted on the magazine's website and is being published in its March 25 edition.

"Secretary Shinseki has one of the toughest jobs in America," said Hamilton, a combat wounded Marine Corps rifleman in Vietnam. "It is his responsibility to heal, help and care for our wounded, ill and injured veterans from all generations. What he doesn't need is criticism from those who have little or no understanding of the real issues or challenges facing his department."

In his column, Klein criticizes Shinseki for being quiet and reserved, as if the secretary of the nation's largest integrated healthcare network and second largest federal department has time for a publicized social life. Klein hides behind a so-called "legion" of Iraq and Afghanistan veterans who say the secretary lacks the creativity and leadership skills to run the VA, plus sympathizes with their complaint of not being moved to the front of the line ahead of other – but older – disabled veterans. Still worse, Klein accuses Shinseki of not capitalizing on the mass murder allegedly committed by an Army staff sergeant in Afghanistan.

"What occurred in Afghanistan was a tragedy, not an opportunity," said Hamilton. "The Department of Defense and the VA expend an enormous amount of resources on programs and outreach to provide mental health counseling to those in need, but you can't mandate any program that first requires someone to

voluntarily step forward and ask for help. That same limitation also confronts all of us who are in this battle to end military and veteran suicides.

"And regarding the columnist's personal attack, just because the secretary prefers a lower profile to someone who might 'Tweet' their every movement doesn't mean he doesn't care. It just means he's too busy doing his job, and that's to fulfill our nation's promise to her veterans."

For years the VFW has testified before Congress about the lack of funding for the VA's Veterans Benefits Administration, especially in the areas of automation and proper staffing. Hamilton said the secretary did the absolute right thing to grant additional presumptive service connections for Vietnam and first Gulf War veterans, but he acknowledged that organizations like the VFW and others who employ service officers to help veterans file their claims knew that the increased workload would overwhelm the existing system.

Thanks to the president and Congress, the VA now has the necessary resources to automate the claims processing system. This means the VA is moving in the right direction, said the VFW national commander, but after years of neglect, the fix will not come overnight.

"We want the VA to succeed, and that's why we work closely with Secretary Shinseki and his staff to help identify and correct problems in a professional manner from within, not by enlisting the media to sensationalize issues the great majority of Americans and, quite frankly, many veterans don't understand," said Hamilton.

"The VFW helped to create the VA in 1930. We will not let it fail. We will also continue to take strong issue with people who blindly criticize the organization or its secretary, who is a combat wounded veteran who understands what it means to serve and sacrifice. Secretary Shinseki gets it, and America should be very appreciative that he volunteered to stay for another tour – the VFW is."

**Tuition Assistance Amendment**  
**Passes Senate Thanks to VFW Advocacy**  
**VFW members were highly involved**  
**in push to reinstate Tuition Assistance**

March 20, 2013 – This afternoon the Senate passed an amendment to the Defense Continuing Resolution, H.R. 933, that will reinstate the military Tuition Assistance or TA program under sequestration. The amendment, S. Amdt. 72, was introduced by Sens. James Inhofe, R-OK, and Kay Hagan, D-NC, and championed by the VFW, The American Legion and Student Veterans of America.

On Monday, VFW Commander-in-Chief John Hamilton sent an “all hands” call to VFW advocates in an effort to muster support for the Inhofe/Hagan amendment. On Monday afternoon, Senate debate over the continuing resolution stalled before the amendment could be considered, leading many on Capitol Hill to believe that hope for restoring TA through the continuing resolution was lost. Inhofe and Hagan quickly scrambled to introduce stand-alone legislation to reinstate TA through S. 614 and a House companion bill, H.R. 1265.

Fortunately, VFW advocacy was unrelenting. In two short days, VFW advocates generated more than 12,000 calls and emails to Senate and House offices from every state, and this morning, Senate Majority Leader Harry

Reid, D-NV, presented the amendment to the Senate floor without objection. It officially passed through voice vote late in the afternoon.

The Inhofe/Hagan amendment will require each military branch to continue operating their respective TA programs proportionate to the sequester. Currently, the Army, Air Force, Coast Guard and Marine Corps have cut off TA enrollment entirely in an effort to generate greater savings through budget sequestration.

The Marine Corps was the first branch to announce its suspension of TA under sequestration. Since then, the VFW has heard from countless service members across each service wondering what to do next. The VFW has been a longtime proponent of the military’s TA programs and has been working diligently to reinstate and preserve the benefit since the Marine Corps’ announcement.

The Senate will now vote on the full continuing resolution, H.R. 933, to fund the departments of Defense and Veterans Affairs through the remainder of fiscal year 2013. Your VFW will keep you posted on our efforts to reinstate military TA as the continuing resolution moves through Congress.
