## **SENIOR VICE COMMANDER**



Tradewell married Sharon in 1966 and they make their home in Sussex, Wisconsin.


## ADJUTANT/QUARTERMASTER

#### **Advocating for Others**

In a TV show, *The Myth Busters*, hosted by Jamie Hyneman and Adam Savage – and co-hosted by Tory Belleci, Kari Byron and Grant Imahara – they mix scientific methods with gleeful curiosity and plain old-fashioned ingenuity to create their own signature style of explosive experimentation.

Sometimes we have those that are in the veteran community, who share myths as fact, and although they are not an explosive experimentation such as the TV show, they sometimes produce havoc with those that believe them.

One of the most common myths that a veteran may share with a spouse is that, "When I die, you will get the same thing I got from the VA." Not true. When a veteran passes, the claim dies, and the spouse must file in their own right. There is no guarantee that a spouse will be entitled to anything unless certain eligibility requirements have been met, and a claim has actually been filed.

Some think that the VA can take away the grant of entitlement to the issue of service connection for just about any reason. This is not true.

**§3.957 Service connection.** Service connection for any disability or death granted or continued under Title 38, United States Code, which has been in effect for **10 or more years** will not be severed except upon a showing that the orig-

inal grant was based on **fraud**, or it is clearly shown from military records that the person concerned did not have the **requisite service** or **character of discharge**. The 10-year period will be computed from the effective date of the Department of Veterans Affairs finding of service connection to the effective date of the rating decision severing service connection, after compliance with §3.105(d). The protection afforded in this section extends to claims for dependency and indemnity compensation (DIC), or death compensation. (Authority: 38 U.S.C. 1159).

Another common myth is that veterans who have had a service-connected disability rating in effect for a long period of time (20 years or more) think that if they ask for an increase from the VA, they will be reduced. This, too, is not true.

38 CFR 3.951 (b) preservation of disability ratings (b) A disability which has been continuously rated at or above any evaluation of disability for 20 or more years for compensation purposes under laws administered by the Department of Veterans Affairs will not be reduced to less than such evaluation except upon a showing that such rating was based on fraud. The 20-year period will be computed from the effective date of the evaluation to the effective date of reduction of evaluation. (Authority: 38 U.S.C. 110).

Another issue that seems to surface from

time to time is that a veteran will request an entire copy of their VA claims folder, then send that copy back to the VA to consider an issue that has already been dealt with by the VA. This is redundancy. In order for the VA to revisit a previous adjudicate issue, new and material evidence must be submitted. That is, new evidence that has never been considered and is germane to the issue being addressed.

Finally, this is more confusion than a myth is, but it deals with when a grant for multiple disabilities and the percentage just doesn't add up. For instance, a left knee condition is evaluated at 30%, a back condition rated at 40%, and a heart condition rated a 60%. It doesn't take a rocket scientist or a math wizard to add 60 + 40 + 30 and get 130%. Right? Not really. The VA uses what is called a "combined rating table" under **38 CFR 4.25**.

The Combined Ratings Table results from the consideration of the efficiency of the individual as affected first by the most disabling condition, then by the less disabling condition, then by other less disabling conditions, if any, in the order of severity. Thus, a person having a 60% disability is considered 40% efficient. What this means is that we start with a 100% efficient body. After subtracting the 60% disability, our body's efficiency that is left, is only 40%. Proceeding from this, the effect of a further 40% disability is to





leave 24% efficient. How the heck did you get that you might ask? We multiply the 40% efficient by the additional 40% deficient and low and behold, we get 16%. So add the 16% to the previous 60%, and we get 76%. This 76% is then subtracted from the initial 100%, and we get 24% remaining efficiency. Proceeding with the final disability of 30% multiplied by the remaining 24% efficient, we arrive at 7.2%. This 7.2% is then added to the previous 76% and we get 83.2%. This individual is thus 80% disabled, because the VA rounds up and down accordingly. The veteran's remaining efficiency is 16.8%.

Believe it or not, based on this formula, in order for a veteran to be a scheduler 100%, the veteran would need an additional 70% disabling condition. Yep, only in America!

After reading this three or four times, walk around the room, let the dog out, scratch your head a couple of times, and if you still don't understand it, don't feel bad. It took us a long time, too. Fortunately, there is a chart that we use under 38 CFR 4.25.

# Department Service Officer SUCCESS STORY

Just when you think you have seen it all, a story presents itself that would make many believe that this could not happen!

In January of 2011, one of our Advocates received a call from a veteran regarding a situation that needed our immediate attention. After getting the veteran's phone number, a call was made to get the details. The scenario was that we had a Vietnam veteran who stated that he filed a claim in February of 2008 with another Veterans Service Organization for diabetes and ischemic heart disease, secondary to his service in Vietnam. He also stated that he could not work because of these conditions. In the same conversation he stated that the VA denied his claim in the summer of 2008, because he did not provide medical evidence to support his contentions. He further stated that within a month or so after the denial, he provided the necessary information to the VA.

Our Advocate found out that his claim was submitted to the VA under his social security number and that according to the VA records, three things were apparent.

1) the VA had set up a pending claim for Individual Unemployabilty (IU); 2) the VA had not verified the veteran's military service; and 3) there were no medical records he said he sent to the VA.

We asked the veteran at length about his military service and tour of duty in Vietnam and it was quite evident to us that veteran was giving us correct information. Our Advocate searched high and low for several days for the claims folder to no avail. We were able to ascertain the initial claim was filed under his social security number. Finally, we located the folder and found it with very limited information. It was obvious to us that there may be another claim folder with other indentifying infor-

mation. So the hunt was on! For one week...two weeks...and finally, we found it.

Low and behold, the folder was under a VA claim number. What's the difference between a social security number and a VA claim number? On July 1, 1973 the VA switched from a designated VA claim number (eight digits) to a veteran's social security number (nine digits). What this means is that our veteran either filed a claim for disability or an educational claim, prior to the above note date and was issued an eight digit number. We had two claim folders!

In any event, we still had a veteran not service-connected with a claim for IU for the better part of three years. The question that was proposed to the VA is, how can an issue of IU even be considered when the veteran isn't even service-connected for anything? The answer – does the image of a deer in the headlights come to mind?!

In addition, there were two, count them two, Congressional inquiries that didn't move the mountain. After we were able to merge both files, the VA took the bull by the horn and issued a rating within 24 hours of our discovery!

Due to the severity of the veteran's heart and diabetic condition, the issue of IU was moot. The veteran was granted a 100% evaluation from the initial date of claim and the veteran was sent a retro check in the amount of \$95,000 on March 1, 2011. When contacted by our Advocate to share the good news, the veteran and his wife explained that they had been cutting back on their propane all winter to save for food. Today, they have a full tank, a full tummy and are warm and very thankful for the Advocates of the VFW who exemplify the VFW Motto, "Honor the Dead by Helping The Living."

## **URGENT MESSAGE!!!**

#### from the Service Director Daniel J. Crocker

After writing my article for this month's edition of the *MOV*, we became aware of a situation that may cause a lot of our veterans concern.

There has been a recent publication printed here in the state of Michigan that has alluded to new entitlement for Blue Water Navy veterans to receive benefits under the Agent Orange Act, as a result of service offshore in Vietnam.

The article refers to the *Hass v. Nicholson* case and in previous editions of the *MOV*, we have advised our readership that this case was overturned.

On May 8, 2008, the Federal Circuit issued its decision in *Haas v. Peake*, 525 F, where it reversed the Veterans' Court, holding that the Veterans' Court had erred in rejecting VA's interpretation of § 3.307(a)(6)(iii) as requiring a service member's presence at some point on the landmass or inland waters of Vietnam in order to benefit from the regulation's presumption. The Federal Circuit issued a mandate in Hass, effective October 16, 2008 (setting forth federal rules of appellate procedure with respect to issuance of mandate and staying of mandate pending petition for certiorari).

That same day, the appellant in Ribaudo filed a motion for leave to file a motion to modify the Veterans' Court's April 13, 2007 per curiam order to state that the stay effectuated in Ribaudo would expire either when the United States Supreme Court (Supreme Court) denied the petition for a writ of certiorari in Haas or decided Haas on the merits, rather than expiring on the date that the Veterans' Court issued the mandate in that case. The Veterans' Court denied the motion on November 17, 2008, noting that the April 13, 2007 Ribaudo order, which merely stayed the implementation of its own Haas decision, had become final upon issuance of the mandate on May 17, 2007. The appellant in Haas filed a petition for a writ of certiorari to the Supreme Court, which was denied on January 21, 2009. See Haas v. Peake, 77 U.S.L.W. 3267 (Jan. 21, 2009) (No. 08-525).

As the Ribaudo stay of Haas-related cases is no longer in effect, and in light of the Supreme Court's denial of certiorari, VA's Office of General Council has advised that the Board may resume adjudication of the previously stayed cases.

The bottom line is that at this current time, there is no entitlement for Blue Navy Vets unless they step foot on land or have been identified as part of a ship's crew that has been recognized by the Department of Veterans Affairs, which been previously published in the *MOV*, and the list continues to grow.

If there is any change in the law, we will be the first to let our readership know!

## **DISTRICT 6 REPORT**

Greetings Comrades,

This will be my last article as your District Commander. We have completed 9.5 months of VFW Year 2010-2011 and 11 months out of our reporting year. The only thing we need to do is finish strong in membership. This is my third year monitoring membership, and I hope we change a recurring trend. The trend is we gained 123 new members and reinstated 75 for a total of 198. This in itself is good, as the District could meet its 102% goal. Now the downside: we have 311 unpaid members from the last year. That means we have a net loss of 113 members for the District. We still needed 208 renewed members for 100% and 305 members for 102% in the District. Hopefully, we will have attained that goal by the 30th of April.

I have stated before that if the All-State program is "Queen", then our Membership Program is "King". We cannot accomplish the mission of our corporation without members. Members give us the work force to accomplish the All-State program. Members give us the numbers we need to collect the donations to support the All-State program. The All-State program, when reported correctly, provides the proof to the IRS that we are a nonprofit corporation.

How have we fared this year? Donations are down about 30% this year. Membership is down 4.32%. We have 11 Posts that have attained 100-116.87% in membership. We have five Posts who have achieved 130-188 points in the All-State program. We have six Posts that have achieved 90% or greater of the 125 points District goal; two Posts who have achieved 80% or greater, six Posts who have achieved 60% or greater and 13 Posts that scored below the 60th percentile. I will provide my final report to the Post Commanders at the 6th District Caucus at the State Convention in Troy. Every program will have been

completed by then, except membership, which continues until 30 June.

I ask all comrades to examine their Posts and ask yourselves one question. Are we operating as a VFW in accordance with the Bylaws and Manual of Procedures and other Bylaws as approved by the Commander-in-Chief? Or are we operating more like a social club? If it is the latter, than vote to surrender your VFW Charter and become a social club.

I have had the opportunity to visit all the Posts in our District. I have listened to their committee reports and what they have accomplished in the preceding month. All they had to do was report their activities, via the Activities and Hospital Reports to Department on time (prior to the 10th of the month), and all Posts in the District would have reported over 125 All-State Points. This is not a competition, it is the measure to see if you're supporting the established VFW National and State Programs and; more importantly, justify our nonprofit status to the IRS. District stats are as follows: Hospital program: 1,973 Workers, 8615.25 Hours, \$19,922.84 in Donations, \$41,201.00 in Hospital Equipment Loaned, 6,014 Patients Visited, 35,664 Miles Driven, 180 pints of blood were given and cancer donations were \$1,924.62.

Activities Reports: CS Projects 4,323, CS Hours 35,007, CS Value \$321,572.38, AM Projects 2,941, YA Projects 480, YA Hours 4,634, YA Value \$93,666.87, DR Projects 131, SA Projects 97, Legislative Projects 113 and PAC Projects \$1,055.00. Not bad for 11 months of reporting. Just think what the numbers would have been if everyone reported what they actually did.

I would like to congratulate Lloyd F. Putman II and Patricia Paterson on their successful completion of VFW Year 2010-2011 as Department Commander and President. May all your future endeavors be as successful as this year has been.

# Uniform Committee Gives Search Update

At the National Council of Administration Meeting at the Mid-Year Conference, Uniform Committee Chairman Kathy Schreiber updated members on the struggles they have faced in talking to new uniform companies. The contract with Cintas Uniform Company has been officially terminated, and the current marine blue uniform is no longer available to order. The Committee was formed by National President Cortina Barnes to investigate new possibilities.

"It's been very difficult," Schrieber acknowledged. The Ladies Auxiliary VFW had certain requirements: broad range of sizes, reasonable prices and no potentially restricting contract. They quickly found out that the marine blue of the current uniform is a custom color and would be priced as such. Nearly everything presented to the committee

was too expensive, close to or more than the current uniform.

"We're not prepared to make a recommendation at this time," Schrieber said at the Council Meeting. "But we would like you to consider this option." The committee

## Southfield, Michigan Vascular Surgeon Provides "Hands-On" Support for the Troops

CHICAGO – For two weeks, vascular surgeon Kevin Nolan of Southfield, Michigan, volunteered to treat wounded American soldiers transported from Afghanistan and Iraq to the U.S. Army's Landstuhl Regional Medical Center (LRMC) in Germany.

"I volunteered – both this time and back in June 2008 – because it was an opportunity to demonstrate to the men and women who are being asked to do their jobs in a hostile environment (often times getting injured or killed) that American civilians like myself and my vascular surgical colleagues appreciate and respect the sacrifice they are being asked to make and will support them with our time and our surgical skills," said Dr. Nolan, Chief of the Section of Vascular Surgery at Providence Hospital and Medical Centers in Southfield, Michigan.

"There is no doubt that being able to help these courageous individuals is personally rewarding. The emotion felt among the caregivers – and there are many providing care from every discipline in medicine and nursing – is not easily described. Suffice it to say, it's a moving experience, and one in which I am both humbled and privileged to have been involved."

From January 22 to February 6, 2011, Dr. Nolan volunteered at LRMC – the largest American hospital outside the United States. Since 2004, 66,000 military personnel have been treated at LRMC.

Since Sept. 2007, 72 Society for Vascular Surgery\* (SVS) members have volunteered to supplement the limited number of vascular surgeons at the medical center. "Speaking on behalf of SVS leadership and all of its members, we are extremely proud of the vascular surgeons who donate their time to help treat war injuries," said 2010-2011 SVS President Dr. Robert Zwolak of New Hampshire.

"Vascular surgeons repair damaged arteries and veins through traditional



open surgical techniques. Our member volunteers are determining the value of endovascular methods in these most challenging and difficult cases."


In 2007, SVS member and retired U.S. Army Col. David Gillespie of the Office of the U.S. Army Surgeon General and professor of surgery at Walter Reed Army Medical Center in Washington, D.C., asked Society members to share their medical expertise as volunteer surgeons at LRMC. Immediately, SVS members responded to support the troops. Currently, there is a waiting list for SVS surgeons who are willing to volunteer at LRMC during 2011.

## **POW/MIAs Recovered**

WWII MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belonging to Army Air Forces Capt. George W. Grismore, of Salt Lake City. On March 12, 1945, Grismore and five crewmembers aboard a C-47A Skytrain departed Tanauan Airfield in the Philippines on a resupply mission to guerilla troops. The aircraft did not return to base, and no evidence of the aircraft was found. The six men were presumed killed in action and their remains were later determined to be nonrecoverable. Korean War MIA Identified: DPMO also announced the identification of remains belonging to Army Cpl. Floyd E. Hooper, of Stratton, CO. Fighting as a member of the 24th Infantry Division, he was captured on Feb. 4, 1951, and died of malnutrition and dysentery a few months later. Between 1991 and 1994, North Korea gave the United States 208 boxes of remains believed to contain the remains of 200-400 servicemen. Among other forensic identification tools and circumstantial evidence, scientists from the Joint POW/MIA Accounting Command used dental comparisons and mitochondrial DNA – matched to his brother – to identify Hooper. WWI, Korean War MIAs Identified: The Defense POW/Missing Personnel Office announced the identification of remains of two soldiers who had been missing-in-action from World War I and the Korean War. Army Private Henry A. Weikel, of Mt. Carmel, PA, was killed on Sept. 16, 1918, when his unit came under attack east of Paris near Jaulny, France. He was assigned to the 60th Infantry Regiment, 1st Brigade, 5th Infantry Division. Army Sgt. First Class Wallace L. Slight, of Yates City, IL, was killed on Nov. 1, 1950, when enemy attacks collapsed their defensive position in North Korea, along the Nammyon River. He was assigned to M Company, 8th Cavalry, 1st Cavalry Division. Korean War MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belonging to Air Force 1st Lt. Robert F. Dees, 23, of Moultrie,

Ga. On Oct. 9, 1952, Dees was piloting an F-84 Thunderjet against enemy railcars near Sinyang, North Korea. All contact was lost with him after an explosion near the target was observed by other flight members. In 1954, North Korea turned over remains reportedly recovered from Sinyang, but Army mortuary affairs was unable to identify the remains, which were subsequently buried as "unknown" in the National Cemetery of the Pacific in Honolulu. Eleven WWII MIAs Identified: The Defense POW/Missing Personnel Office announced the identification of remains of an 11-man B-24D Liberator crew that had been missing in action since Nov. 20, 1943, when the aircraft took off from Port Moresby in New Guinea but failed to return to base. Subsequent searches failed to uncover any evidence of either the aircraft or crew, so in June 1949, the Army Graves Registration Service concluded that all were unrecoverable. Korean War MIA Identified: The Defense POW/Missing Personnel Office announced the identification of remains belonging to Army Cpl. John W. Lutz, 21, of Kearny, NJ. From May 16-20, 1951, Lutz was captured when hid 1st Ranger Infantry Company was attempting to infiltrate enemy lines near Chaun-ni, South Korea. WWII MIA Identified: The Defense POW/Missing Personnel Office also announced the identification of remains belonging to Army Air Forces 2nd Lt. Martin P. Murray, 21, of Lowell, MA. On Oct. 27, 1943, Murray, along with 11 other crew members, took off in their B-24D Liberator on a reconnaissance mission of shipping lanes in the Bismarck Sea. The aircraft failed to return to base. ## War Dog Cemetery

When one hears the word cemetery we all think about where mom, dad or Uncle Ralph are buried. However, have any of us thought that military "hero dogs" have their own area for their eternal rest?

Located outside of South Lyon, Michigan at the corners of Eleven Mile and Milford Roads is an acre sanctuary devoted specifically for these "hero dogs" that are popularly known as military service dogs. The



site gives honorable tribute to these fourlegged unsung heroes who would have given their lives, if needed, to protect their masters and fellow troops.

The cemetery began in 1946 in honor of "Sparks" who fought with the Marines on Guadalcanal in 1943. Many others have joined Sparks since his interment in the past 65 years. An erected five-foot monument at the burial site pays tribute to the K-9's who served their country in both World Wars. The stone marker reads, "Dedicated to the

memory of THE WAR DOG erected by veterinarians, humane organizations and the dog loving public to perpetuate kindness to man's most faithful friend for his heroic services in World War I and II."

We can only hope that many of these four-legged heroes returned to the United States after their service was completed and lived a happy remaining life with their masters as a just reward for their valiant service; and for those that died in service to their country, recognition has been given to them for a job well done.

## **Veteran Borrowers in Delinquency Quick Reference Sheet**

#### **General Guidance**

The US Department of Veterans Affairs urges all veterans who are encountering problems making their mortgage payments to speak with their servicers as soon as possible to explore options to avoid foreclosure. Contrary to popular opinion, servicers really do not want to foreclose because foreclosure costs a lot of money. Depending on a veteran's specific situation, servicers may offer any of the following options to avoid foreclosure:

- Repayment Plan The borrower makes regular installment each month plus part of the missed installments.
- Special Forbearance The servicer agrees not to initiate foreclosure to allow time for borrowers to repay the missed installments. An example of when this would be likely is when a borrower is waiting for a tax refund.
- Loan Modification Provides the borrower a fresh start by adding the delinquency to the loan balance and establishing a new payment schedule.
- Additional time to arrange a private sale – The servicer agrees to delay foreclosure to allow a sale to close if the loan will be paid off.
- Short Sale When the servicer agrees to allow a borrower to sell his/her home for a lesser amount than what is currently required to payoff the loan.
- Deed-in-Lieu of Foreclosure The borrower voluntarily agrees to deed the property to the servicer instead of going through a lengthy foreclosure process.

Servicemembers Civil Relief Act Veteran borrowers may be able to request relief pursuant to the Servicemembers Civil Relief Act (SCRA). SCRA is intended to ease the economic and legal burdens on military personnel during their active service. In order to qualify for certain protections available under the Act, the borrower must request protection under the Act, and the loan must have originated prior to the current period of active military service. SCRA may provide for a lower interest rate, or prevent foreclosure or eviction up to nine months from period of military service.

#### Assistance to Veterans with VA-**Guaranteed Home Loans**

When a VA-guaranteed home loan becomes delinquent, VA provides supplemental servicing assistance to help cure the default. The servicer has the primary responsibility of servicing the loan to resolve the default. However, in cases where the servicer is unable to help the veteran borrower, Loan Guaranty has Loan Technicians in eight Regional Loan Centers and two special servicing centers who take an active role in interceding with the servicer to explore all options to avoid foreclosure.

Veterans with VA-guaranteed home loans can call 877-827-3702 to reach the nearest Loan Guaranty office where loan specialists are prepared to discuss potential ways to help save the loan.

#### **National Call Center** for Homeless Veterans

Veterans who feel they may be facing homelessness as a result of losing their home can call 877-4AID VET (877-424-3838) or go to www1.va.gov/HOMELESS/National CallCenter.asp to receive immediate assistance from VA.

#### Assistance to Veterans with non-**VA Guaranteed Home Loans**

For a veteran or service member who may have obtained a conventional or sub-prime loan, VA has a network of eight Regional Loan Centers and two special servicing centers that can offer advice and guidance. Borrowers may visit VA's Web site at www.benefits.va.gov/homeloans or call toll-free 877-827-3702 to speak with a VA Loan Technician. However, unlike when a veteran has a VA-guaranteed home loan, VA does not have the legal authority to intervene on the borrower's behalf. It is imperative that a borrower contacts his/her servicer as quickly as possible.

#### VA Refinancing of a non-VA **Guaranteed Home Loan**

Veterans with conventional home loans now have new options for refinancing to a VA-guaranteed home loan. These new options are available as a result of the Veterans' Benefits Improvement Act of 2008. Veterans who wish to refinance their subprime or conventional mortgage may now do so for up to 100% of the value of the property, which is up from the previous limit of 90%.

Additionally, Congress raised VA's maximum loan guaranty for these types of refinancing loans. Loan limits were effectively raised from \$144,000 to \$417,000. High cost counties have even higher maximum loan limits. VA County Loan Limits can be found at www.benefits.va.gov/homeloans. These changes will allow more qualified veterans to refinance through VA, allowing for savings on interest costs and avoiding foreclosure. A VA refinancing loan may help a veteran who is facing a big payment increase.

#### Other Assistance for Delinquent **Veteran Borrowers**

If VA is not able to help a veteran borrower retain his/her home (whether a VA-guaranteed loan or not), the HOPE NOW Alliance may be of assistance. HOPE NOW is a joint alliance consisting of servicers, counselors, and investors whose main goal is to assist distressed borrowers retain their homes and avoid foreclosure. They have expertise in financial counseling, as well as programs that take advantage of relief measures that VA cannot. HOPE Now provides outreach, counseling and assistance to homeowners who have the willingness and ability to keep their homes but are facing financial difficulty as a result of the crisis in the mortgage market. ## Last Surviving WWI Veteran Has Passed

The following is a statement from VFW Commander-in-Chief, Richard Eubank.

February 28, 2011

The passing of Mr. Frank Buckles marks the final departure of the last surviving link to the more than 2 million American men and women who served during World War I. Sadly, this generation of heroes has surrendered to time and the day has come when they no longer walk among us.

World War I unleashed an unrestrained, methodical and mechanized destruction of human life leaving more than 8 million dead and 21 million wounded. Our late entry into the war in 1917 helped stop the slaughter in Europe, but at a heavy price to the nation; 126,000 deaths and more than 200,000 wounded by the end of the war in 1918. Despite the extremes of the war: fear, courage, cruelty and compassion, America made a conscious decision to fight for the ideal of freedom.

The full scope and stark reality of that war was beyond all of us, with the exception of one man who represented an entire generation assigned to history. Frank Buckles' service and that of his now-absent comrades was borne from neither bravery nor bravado. It came from within; a sense of selflessness...doing something good for others, despite the danger. They faced fear and accepted it, challenged it, fought it, and then acted with honor. That is their legacy to us.

And that's why we must ensure the memory of their courage and sacrifice won't fade or disappear into anonymity. That would be an irretrievable loss to the nation, one that we cannot afford to pay.

Editor's Note: Mr. Buckles was a lifelong VFW member who was buried in Arlington National Cemetery. Out of respect for his passing and that of his entire generation, the President ordered the U.S. flag to be flown at half-staff on the day of his interment.

## Congress to, 'Do What is Right for America's Only True Heroes' VFW pays visit to Capitol Hill to remind leaders

**VFW National Commander Urges** 

of its high priority issues.

March 08, 2011 – Richard L. Eubank, the National Commander of the Veterans of Foreign Wars of the U.S., delivered testimony today before a joint hearing of the Senate and House Veterans Affairs Committees.

In his presentation of the VFW's national priorities, Eubank, a Marine Corps retiree and Vietnam combat veteran from Eugene, Ore., urged congressional members "to do what is right for America's only true heroes" by fully funding the VA, even as lawmakers wrestle with efforts to rein in federal spending. Eubank, who leads the nation's largest and oldest major combat veterans' organization, reminded committee members of the heavy burden placed on current service members, veterans and their families.

"There is a tremendous cost of war, most especially on those men and women who fight it. And that the consequences of defending America do not end when the last bullet is fired."

Eubank reiterated the legislative concerns of the veterans' service organization.

"Thousands dead, tens of thousands wounded, and hundreds of thousands more who came home to unemployment, broken families, and memories that will be there for the rest of their lives," he said. "Suicides are at record highs in the military and in the veteran's community. PTSD, TBI, substance abuse...the list of ailments and challenges our veterans face is a long one, and it goes hand-in-hand with a decade of serving faithfully in two wars on the other side of the globe. In no uncertain terms, the VFW believes the aftermath of war on service members and their families must be recognized as a cost of war."

In his testimony, Eubank praised the VA healthcare system, but was critical of the Veterans Benefits Administration. "While the VA health care system is a 21st century health care system delivering world-class care to America's veterans, the Veterans Benefits Administration continues to struggle with the greatest workload in over 50 years, and the worst quality in decades."

Eubank explained that the current backlog of claims for compensation and pension, education, and those on appeal, currently sits at almost 1.5 million, and that the reported adjudication error rate of 16 percent is much higher for claims dealing with such as Traumatic Brain Injuries, PTSD and diabetes.

The VFW National Commander thanked VA Secretary Eric Shinseki for his "courage and steadfastness" to add three new illnesses to the list of presumptive illnesses related to Agent Orange exposure. "His determination to do what was right for veterans has earned him our admiration and gratitude," he said.

Other VFW high priority issues include the proper care and treatment of returning servicemen and women with severe injuries to mind and body, the need for an integrated information technology system, veterans' unemployment and education, military caregivers and survivor benefits, and the need to sustain and enhance government search and recovery efforts for unaccounted-for Americans from all wars. Eubank also provided testimony regarding further traumatic brain injury research and treatments, suicide awareness and prevention, and women veterans' health care needs.

Joining Eubank at the hearing were hundreds of VFW and Ladies Auxiliary leaders from all 50 states, the District of Columbia, Europe, the Pacific, Latin America and the Caribbean. It was followed by individual meetings between VFW members and their respective members of Congress.


