
# SENIOR VICE COMMANDER

# ADJUTANT/QUARTERMASTER

#### Advocating for Others

Over the years, veterans talk to one another and share what benefits they think they are entitled to and what benefits they think other veterans should be entitled to. Unfortunately, somewhere between the discussions that take place, reality surfaces and misinformation is disseminated.

One such entitlement that is commonly misunderstood is the full exemption of property taxes here in the State of Michigan. For that reason, I have taken the liberty to insert the full text of Public Act of 1893; 211.7b

211.7b Exemption of real estate used and owned as homestead by soldier or sailor discharged with service connected disability; filing and inspection of certificate and affidavit; cancellation of taxes; local taxing unit to bear loss; death of soldier or sailor; continuation of exemption in favor of unremarried surviving spouse. **Sec. 7b.** 

- (1) Real estate used and owned as a homestead by a soldier or sailor who was discharged under honorable conditions with a service connected disability, and who has a certificate from the United States veterans' administration, or its successors, certifying the soldier or sailor is receiving or has received pecuniary assistance due to disability for specially adapted housing, shall be exempt from taxation. To obtain the exemption an affidavit, accompanied by the certificate, showing the facts required by this section and a description of the property shall be filed with the supervisor or other assessing officer. The affidavit and accompanying certificate shall be filed during the period beginning with the tax day for each year and ending at the time of the final adjournment of the local board of review. The affidavit and accompanying certificate when filed shall be open to inspection. The county treasurer is hereby authorized, pursuant to section 55, to cancel the taxes for any year in which a soldier or sailor has acquired title to real estate exempt under this section. Upon the granting of the exemption as allowed in this section, each local taxing unit shall bear the loss of their portion of the taxes upon which the exemption has been claimed and allowed.
- (2) If a soldier or sailor entitled to the exemption permitted by this section dies, the exemption shall continue in favor of the unremarried surviving spouse of the soldier or sailor. The spouse shall comply with the requirements of subsection (1) and shall indicate on the affidavit that he or she is the surviving spouse of a soldier or sailor entitled to exemption by this section. The exemption shall continue as long as the surviving spouse remains unremarried. In layman's terms the property taxes for

the primary residences of a veteran whom has a service-connected disability requiring the adaptation of his/her home because of that specific condition and has been preauthorized and subsequently paid for by the VA can have property taxes exempted.

The Department of Veterans Affairs (VA) will certify this element that in fact the adaptation has taken place and that the VA paid for the alteration.

Some seem to think that a 100% serviceconnected veteran is entitled to this exemption. Fortunately or unfortunately, the percentage of evaluation for a serviceconnected disability has little to do with the entitlement under this Public Act.

On another note, thousands of veterans may be entitled to a special pay as a result of the Stop Loss Policy that extended enlistments for those on active duty. A service member must apply for this, but attempts to find those that may be eligible have been made through the VA and other media sources.

Those eligible must submit their claim by March 4, 2011.

The DoD Web site at http://www. defense.gov/stopploss links to service-specific sites, where you can get more information, or begin the RSLSP claim process.

The 2009 War Supplemental Appropriations Act established **Retroactive Stop Loss Special Pay (RSLSP)**, providing \$500 for each month/partial month served in stop loss status. Service members, veterans, and beneficiaries of service members whose service was involuntarily extended under Stop Loss between Sept. 11, 2001 and Sept. 30, 2009 are eligible for RSLSP.

To receive this benefit, those who served under stop loss must submit a claim for the special pay (by March 4, 2011). Throughout the year, the services have been reaching out to service members, veterans and their families through direct mail, veteran service organizations, and the media. But there is still money left to be claimed, and the deadline is approaching.

#### The average benefit is \$3,700. Note on Eligibility

Effective Dec. 19, 2009, per the Defense Appropriations Act, stop-lossed service members who voluntarily reenlisted or extended their service, and received a bonus for such reenlistment or extension of service, became no longer eligible to receive retroactive stop loss special pay.

#### General Procedure

Individuals who meet eligibility criteria may submit an application between 21 October 2009 and 4 March 2011. By law, there is no authorization to make payments on claims that are submitted after 4 March 2011.

Eligible members should print, complete and sign Department of Defense Form 2944, Claim for Retroactive Stop Loss Payment.

Next, choose the appropriate method for submitting the claim form and available supporting documents based on your service specifications. This information can be found on your service's stop loss Web site.


# Department Service Officer SUCCESS STORY

This story is one that is not uncommon. Unfortunately, this Army Gulf War veteran found out the hard way that sometimes a nut is hard to crack. We, on the other hand, find that a nut that is hard to crack needs a bigger hammer!

Our Combat Infantry Badge soldier served from June of 1990 to October of 1994 with a tour of duty in Southwest Asia.

The veteran filed an informal claim with the Department of Veterans (VA) in May of 2004 for a cervical spine disability and a bilateral knee condition. The veteran contended that his bilateral knee condition was a result of an injury that he sustained while jumping off a truck during combat operations in the Persian Gulf. Additionally, the veteran asserted that this injury was aggravated by the impact sustained after approximately 50 jumps from planes as a paratrooper. Okay, I'll ask the question. "Why does anybody jump out of a perfectly good airplane??"

The VA did not buy his story and in May of 2006 the VA denied his claim. Thus began the time consuming journey of trying to convince the VA that what had happened and the resulting disabilities were not a figment of his imagination. He submitted numerous private medical reports time after time that diagnosed the conditions, only to have the claim turned down. In fact, according to the VA examiner, the veteran did not have any current disability related to his knees, nor did the veteran have a disability during the pendency of his claims since May of 2004. The examiner used the same jargon for the cervical spine. The rationale used by the VA examiner was that he reviewed the VA

claims folder. Gee, that's pretty innovative and interesting?!

Through the advice of our staff member, the veteran decided to have a video conference hearing from the Board of Veterans Appeals (BVA) on January 11, 2011. A decision was rendered on January 21, 2011 with the following findings.

The BVA stated that in order to establish service connection for a claimed disorder on a direct basis, there must be (1) evidence of a current condition disability; (2) evidence of in-service incurrence or aggravation of a disease or injury; and (3) evidence of a nexus between the claimed in-service disease or injury and the disability. The BVA cited Hickson v. West, 12 Vet. App. 247,253 (1999)

With respect to *Hickson* element (1), the veteran was diagnosed in a Report of Examination from the National Guard with mild patella crepitus of his right knee in June 1999. Subsequently, upon review of the veteran's private medical records, to include X-Ray reports, and upon examination of the veteran by his private doctor who opined that the veteran "suffers from Chondromalacia Patella bilaterally ... " The BVA concluded "although there are X-Ray reports of record that do not reflect the presence of abnormalities of the knees, the BVA resolved all doubt in favor of the veteran and found that a current bilateral knee disability exists. Hickson element (1) is therefore satisfied.

With respect to *Hickson* element (2), inservice disease or injury, the veteran contended at the personal hearing on January 11, 2011, that he originally injured his knees when jumping off a truck tionship, the veteran's treating physiwearing full combat gear in an operation during the Persian Gulf War. The veteran also asserts that he continued to hurt his knees during paratrooping exercises occurring at the remainder of his active duty service.

Despite the fact that the veteran's service treatment records include no complaints of, or treatment for bilateral knee pain, the Board finds no reason to doubt the veteran's statements, as evidence of record indicates that the veteran is a combat veteran, his service as an infantry during the Persian Gulf War would have exposed him to situations where mobilizing in heavy combat gear was required. Moreover, the BVA found the veteran's testimony regarding continued knee pain during paratrooping operations credible, as the veteran's DD 214 clearly shows the receipt of the Parachute Badge. Accordingly, the combat presumptions outlined above are applicable in this case, and in-service injury to the knees from combatrelated, as well as from post-combat paratrooping, is demonstrated. Hickson element (2), in serviceinjury is satisfied as well.

Most comrades think we exist to read the prayers at the Post meeting. Is that the purpose of the Chaplain?

The Chaplain exists to minister to veterans and their families. According to our Congressional Charter, the Chaplain "shall be concerned with the spiritual needs of the members, and by precept and example, point the way toward a high moral plane for the organization."

SPIRITUAL GUIDANCE: The Chaplain is available to help individuals and their families with their spiritual needs.

ASSISTANCE IN EMERGENCY SITUATIONS: During crises - hospitalization, injury or death - the Chaplain helps and provides assistance to veterans and their families.

CONDUCTING/ASSISTING AT FUNERALS: The Chaplain assists families with funeral arrangements,

# **ALL-STATE DIRECTOR**

Greetings, Comrades:

The year is winding down and it's time to start wrapping up your All-State program. This will be the last MOV before the program deadline. There is still time to make it. The first and biggest is being 100% in membership – if you're not there yet,

get out and recruit or find your unpaid members. No matter how you do it, just get to at least 100% in membership. The next major hurdle is to obtain 125 points. If you're not there yet – it's not too late, there are plenty of points still available. Just look at the programs.

## **Michigan State Veterans Homes**

The Board of Managers who presides over the two (2) State Veterans Homes of Michigan are appointed by the governor, with the advice and consent of the Senate. Each manager serves a six (6) year term and can be re-appointed upon the recommendation of their respective Veterans Group. The exception is the independent manager solely chosen and appointed by the governor.

The Board of Managers was created by Public Act 152 of 1895. The board exercises certain regulatory and governance authority regarding admission and member affairs at the State Veteran Homes. They also represent the interest of the veterans' community in both advisory and advocacy roles.

The Board of Managers are currently under the umbrella of the Department of Military Affairs (DMVA) which, in turn, is commanded by Major General Greg Vadnais, the new Adjutant General of Michigan. General Vadnais was recently appointed to this high office this past January, 2011, by our new Governor, Rick Snyder. The new deputy director for veterans affairs is retired State Senator Jason Allen from Traverse City.

The Board of Managers and its two (2) state veterans home administrators were given a major challenge over this past month and that is to put together a long range mission and to project a major capital outlay for the future of the residents/veterans of our homes. The operating budgets are increasingly being diminished and the challenge is to cut down to our bare necessities needed to operate, but not to endanger the quality of care for our residents. The Board has taken this very seriously and is responding to the challenge. The new deputy director is allowing the Board to be a major part of the equation in helping solve this crisis.

Members of the Board of Managers consist of seven (7) members; the officers of the Board are voted upon at the Board of Managers Meeting in March of each year within the Board itself. The following is the make up of the Board:

The D.J. Jacobetti Home for Veterans located in Marquette - this home houses some 241 Residents.

- •Domiciliary (ambulatory) 59 beds available, 16.9% filled at present.
- •Nursing Care 182 beds available, 98.90% filled at present.
- •Currently there are 18 members that reside at the Home and are 70-100% service-connected disability. Please get the word out to our veterans that truly need our help!
- •The VA Survey conducted at the D.J. Jacobetti Home in November 2011 produced 0 citations.

Special Note: The Board of Managers is well aware that our state has a \$1.8 billion shortfall for next year's budget and we are very concerned how this will affect the homes.

Just a quick note to say, thank you for your support over this past year and your continued support to assist the veterans at the Grand Rapids Home and the D.J. Jacobetti Home in Marquette.

Finally, the Veterans of Foreign Wars and its Ladies Auxiliary lead the charge in volunteer organizations when it comes to volunteer hours and donations. Thank you, from the two home administrators and the Board of Managers.

# VA Eases Agent Orange Claims for Korean Vets

Under the final regulation published this week in the Federal Register, VA will presume herbicide exposure for any Korean veteran who served between April 1, 1968 and August 31, 1971, in a unit recognized as having operated in or near the DMZ where herbicides were applied. Previously, VA only conceded Agent Orange exposure for certain units between April 1968 and July 1969. VA encourages Korean veterans who may have medical conditions related to Agent Orange exposure to submit their VA claims as soon as possible.



Ihle, Jr. Congratulations again to these Posts, Post Commanders, and their Post members. We have 177 new members so far. We have (8) Posts that could reach 100% by just getting their unpaid members to pay their dues. Go after them and become a 100% Membership Post! I would also like to recognize Post 1669 Royal Oak, Commander Mike Sherman and his Post members. Mike and his Post members have

signed up 32 new members so far. At the time of my writing my article, the 5th District is at 90.36%. We did not reach State Commander Lloyd Putman II's goal of 100%, and I feel bad about that. Don't be discouraged; you are doing a fantastic job. Keep it up! Keep recruiting new members. Our totals as of January 27, 2011 are: 5,886 Life Members, 177 New Members, 69 Reinstated Members and 1,321 Continuous Members for a total of 7,453 members. We are making great progress, but we still have a ways to go to reach our goal of 8,248 members. We have a total of 496 unpaid members. Keep writing, calling or contacting these unpaid members and encourage them to keep their membership in the greatest veterans' organization in the world, the Veterans of Foreign Wars. Please contact 5th District Membership Chairman Jerry Gorski, if you are planning a membership drive. Also, don't forget - we now have (2) VFW Membership Tents in the 5th District. We just received our second new VFW Membership Tent. They are a great way to advertise the Veterans of Foreign Wars at your community events.

Don't forget the All-State program and the District Post Commander of the Year program. This year, a Post must be at 100% in Membership in order to meet the first criteria of both programs. Look at the requirements and points for each listed category. Lastly, check with All-State Director Larry Thayer to see how many points you have accumulated so far. You want to know where you stand for becoming an All-State Post Commander and All-State Post. The District Post Commander of the Year is a separate program from the All-State program. Look at the requirements and add up your points. The Post Commander with the highest number of points will be the District Post Commander of the Year. This recognition will be given out at our last District Meeting "Morning" Session on April 30, 2011.

Don't forget to attend the Monthly Service Officers Meetings in Oakland and Macomb Counties. The VFW, Ladies Auxiliary and Men's Auxiliary should attend to learn about Veterans Benefits that they are entitled to. The District Service Officer, Ken Aune, puts on a School of Instruction at both county meetings. We will also have occasional guest speakers at the Macomb County meetings that give us an update on veterans' benefits.

By the time you read my article, you should be thinking about your incoming officers for 2011-2012. Don't wait until Election Day in April to fill these important positions. You need good future leaders that are capable and willing to make sacrifices of their time and their talents to move your Post forward. Nominations are in March and final nominations/elections are in April.

The last District Meeting of my term will be held at 4156 White Lake on Saturday, April 30, 2011. The combined VFW and Ladies Auxiliary morning session will start at 10:00 a.m. We will be giving out District Awards and the District Commander of the Year Trophy in the morning session. Greetings, Comrades,

We have accomplished eight months of the 2010-2011 VFW year. I have visited 25 out of 27 Posts within the 6th District. Review of our District's progress has revealed the following facts:

•10 Posts can't achieve 100% membership, let alone 102% membership without attaining new members. Collectively, they are 61 members short. The unpaid members for current, plus two years if paid today, will result in the Posts not achieving 100%. The Quartermaster needs to draw the list for 2002-2008 unpaid members in order to attain 100% or recruit 61 new members.

•478 members for current plus two years have not paid their 2011 dues. Yes, it is important to obtain new blood, but we also have to hold on to our existing members. That includes the unpaid membership from 2002 to present.

•19 Posts have attained between 13 and 65 All-State points. 125 All-State Points is the standard measure, to see if a Post is accomplishing the VFW mission. My goal for each Post is still 125 points, but at this stage of the game, 75 points is the 70 percentile and I would consider a Post as accomplishing the mission for this year.

It is still possible for a majority of our Posts to attain 125 points without spending a dime. Commanders review your Commanders Roster! A hint: if the All-State Program is Queen, then Membership is King. The largest amount of All-State points can be obtained from membership. It is actually unlimited. Other areas to consider is the three Safety Programs and three Scouting Programs, not to mention four more points a piece in Community Service, Americanism, Hospital and Legislative. A POW/MIA ceremony reported to a Director is worth three, and attending a ceremony is worth one, up to a total of three. That's 53 points that are attainable if we just work the program; even more if you focus on membership.

While we are on membership, I would like to congratulate the following Posts; 3925 Erie, 3943 Newport, 4076 Chelsea, 5977 Milan, 6056 Springport and 9656 Lambertville for achieving 100% membership. I received Honor Banners for all of them, except Lambertville, at the Mid-Winter Conference. All these Posts will receive their banners at the next District meeting. We have two Posts that are currently eligible for All-American; they are VFW Posts 1138 Monroe and 3925 Erie. In order to achieve the status of All-American, the Monroe Post must achieve a total of 737 members, and Erie must achieve a total of 207 members by 30 June 2011. I have forwarded four different spreadsheets with names, addresses and telephone numbers and even e-mail addresses. You have the tools to accomplish the goal – let's get every member of your Post involved.

In accordance with Section 216 of the National Bylaws and Manual of Procedure, each Post must have elected and appointed officers positions filled. If a vacancy occurs, the Post must fill those vacancies. If you are missing any of these officers, let's get them elected at your next meeting. In the same respect, Section 420 applies to Districts. Our Senior Vice Commander has resigned for personal reasons, and I have accepted the comrade's resignation. In accordance with Section 420, the Junior Vice Commander does not want to succeed to Senior Vice Commander, but will assume the duties until we elect a new Senior Vice Commander at our next meeting. I would like to see a past Commander of either a Post or District step up to the plate and finish out this year as the Senior Vice Commander for the District.

From my point of view, the 6th District is in great shape. We have 27 out of 27 Posts reported in Americanism, 27 out of 27 Posts reported in Community Service, 22 out of 27 Posts reported in Hospital program (cancer donations do not count as a hospital report), and 26 out of 27 Posts reported in Legislative. All-State points range from 23 to 176 points.

I would like to congratulate Kayla F. Winters for a 9th Place finish in the Voice of Democracy competition. She was awarded the Orvel Walter Memorial Scholarship for \$1,000.00.

I would like to end this article with a challenge to our District's Posts. By the next District meeting, I challenge each Post to complete their donation of \$1.00 per member, or \$100.00 if your Post has membership over 100, to the Camp Trotter Maintenance fund, earmarked for the Arts and Crafts Building. If this was accomplished, there would be enough funds to complete the Arts and Craft Building. Keep up the outstanding work.

The 32nd Mid-Winter Conference is over; we are now starting the second half of this year. This was the first time that I attended the Voice of Democracy Banquet and I must say I was very impressed with the way it was handled. Erin P. Hart, an 11th grade student at St. Joseph High School in Benton Harbor, represented Post 1137 for District 7 and she received a \$1,000.00 scholarship. While we were waiting for the presentation to begin, I had the opportunity to talk with Erin's parents and learned that they had just returned from Hollywood, California, where Erin was on the Jeopardy television show! MEN'S AUXILIARY: I have been notified by the State of Michigan VFW that they have still not received election reports from the following Posts: 667, 1137, 1855, 4054 and 6248. Post Commanders, make sure that your Men's Auxiliary President sends a copy to State VFW Headquarters, or get a copy of the election report and send it in, so that theDistrict will be up to date and clear.

The VFW Camp Trotter for Children needs your assistance. All donations should go through Department, but be sure that you earmark the check for Camp Trotter. Also the application for Camp Trotter is online and I hope that you will sponsor a child to go to camp this summer. The fee will be \$200.00 this year. If you get a chance, go see what all the volunteers have done and are planning to do this coming year. Check it out on the Web at www.vfwmi.org/camptrotter

Our National Council of Administration Rep for District 23, William Dobbie, wants to remind all Posts that if you have Bingo, you must file a 990T and that Bingo is non-taxable. However, if you sell any lotto tickets or raffle tickets at a Bingo game, that is taxable. Several VFW's in Michigan have been audited by the IRS and have to pay several thousand dollars in back taxes. Make sure you keep good records.

On May 21, 2011, all newly-elected Post officers should attend the Officers Training School at Camp Trotter. If your Post has new officers, this is the way they will learn what they should be doing. Even if you have been in office, you should also attend just to refresh your memory of what YOU should be doing.

Remember, we now have a District 7 Web site at **www.vfwdistrict7.org**/. The Webmaster is Barry Shackelford from Athens Post – check it out. I think that Barry has put together one of the best Web sites that I have seen. It's better than National's and easier to use.

Remember Poppy Days are May 5, 6 and 7, 2011.

I know everyone is tired of hearing about membership, but without it we wouldn't have any Post nor would the VFW exist. See if there are other issues hindering their membership and ask if they might be able to help with an upcoming function or aid in fixing things up. Do your best to make sure all members feel they are a vital and important piece of your Post and that there is always a place for them. 

Greetings, Comrades and Auxiliary Sisters! Throughout our

travels we are asked by our VFW comrades and friends,

"What is a Cootie?" The Military Order of the Cootie of the United States is a nonprofit veterans service organization. We are known as "The Honor Degree of the VFW" and our members are comprised of the officers and leadership of the Veterans of Foreign Wars of the United States. Membership in the MOC is recognition of outstanding service to the VFW and its programs.

Founded in New York City on September 17, 1920, the MOC is based on the principles of good humor and fun. Over the past 90 years, the Cooties have provided social and entertainment programs to members of the Veterans of Foreign Wars of the U.S. as an ancillary unit within the organization. Since 1923, our first year as a part of the VFW, the Cooties have worked hard to further the aims of the VFW, while adding to it the frivolity known as military humor to the serious work of our parent organization. What would ultimately become known as the VFW National Home for Children, a sprawling campus of homes located in Eaton Rapids, Michigan, started out as the brainchild of the MOC. We firmly believe in caring for the widows and children of our armed forces. Literally, millions of dollars have been raised and donated to help "our kids" over our history; starting with the library, the swimming pool, the Fire Department, and a host of other projects designed to make life fun and educational for the children during their stay at the National Home.

With the outbreak of World War II, the Cooties recognized a need to entertain hospitalized troops and veterans during their confinement and rehabilitation at Veterans Administration facilities throughout the country. Our service program is described as a directive to "Keep em Smiling in Beds of White." Each year, the Cooties volunteer thousands of hours of time worth over \$10 million to DVA hospitals and domiciliaries throughout the United States. This work, in addition to the hours of service donated by active members of the VFW, set the members of the MOC apart as Foreign Service and Combat Veterans who are fully engaged in their communities, their fellow comrades in arms, and their families.

Our distinctive red hat and unusual uniform sets us apart and draws attention to the plight of those less fortunate than ourselves. We sacrifice a little of ourselves to bring a smile or a laugh during what is normally a difficult time for our heroes. We seek others like us to join, to help us help them in their times of stress and anxiety. # **Wounded Warriors Project**

GRAND RAPIDS, Mich. – Iraq and Afghanistan war veterans with traumatic brain injuries can receive free, comprehensive rehabilitation in Grand Rapids through a program funded by the Department of Defense.

Officials from Grand Valley State University and Mary Free Bed Rehabilitation Hospital discussed details of the Wounded Warriors Traumatic Brain Injury Project (WWTBIP) at a news conference November 9 at the hospital. They were joined by U.S. Rep. Vern Ehlers, who was key to securing the \$1.279 million grant from the U.S. Department of Defense that will fund the project.

Ehlers, who will retire after serving Michigan for 17 years in Washington, said he was pleased that he could get funding for the project. "It's really the least we can do for our soldiers," he said. The WWTBIP offers opportunities for standard physical and psychological care, and community support to veterans who sustained traumatic brain injuries while they were deployed in either Afghanistan or Iraq. Jean Nagelkerk, principal investigator and vice provost for health at Grand Valley, said the idea behind this project came from area families with loved ones who received a traumatic brain injury. "We are so excited to be able to provide care and rehabilitation services to wounded warriors and help reintegrate them into society to lead productive lives," Nagelkerk said.

Grand Valley faculty members from the Kirkhof College of Nursing and College of Health Professions will help develop the educational program to enhance the knowledge base of Mary Free Bed staff members who will be directly involved with the veterans.

Dr. Jacobus Donders, co-investigator and chief psychologist at Mary Free Bed, said the services through WWTBIP will not duplicate those veterans already receiving through veterans' hospitals or clinics, but the WWTBIP project will deliver enhanced services such as driver rehabilitation, on-site job evaluation and coaching, and group and family support.

Grand Valley President Thomas J. Haas said announcing the program so close to Veterans Day was appropriate; he also called the men and women serving in Iraq and Afghanistan "the next greatest generation." Those service members include Haas' two sons and daughter.

### **Persian Gulf War Vets Not Forgotten** On this 20th anniversary, let's remember the nearly 700,000 vets of 1991's Operation Desert Storm.

#### January 07, 2011

The following column first appeared in the January 2011 issue of VFW Magazine. Often in history, one war tends to overshadow another. To a certain extent, this has been the case with the Persian Gulf War. Sandwiched between Vietnam and the Iraq/Afghanistan wars, vets of 1991 are sometimes forgotten.

On the war's 20th anniversary it is only appropriate that we commemorate the service and sacrifices of the Americans who evicted Saddam Hussein's Iraq from Kuwait. No one questions the superb welcome home they received in the summer of 1991. But memories of that swift victory in Kuwait have faded over time.

Yet at VFW, this has never been the situation. Besides the 17 articles *VFW Magazine* published in 1991, seven major features since have tracked developments regarding Gulf War illnesses. Two pieces provided a combat overview of the war and a review of its veterans, and a 10th anniversary special was published in 2001. Numerous items of relevant interest have appeared on the pages of *Washington Wire*.

After the homecoming events sponsored by VFW in Kansas City in 1991, VFW's National Veterans Service continued to pursue answers to the questions surrounding what became known as "Gulf War Syndrome." Without question, these mysterious medical maladies constitute the war's enduring legacy for a significant number of veterans.

While pressing health concerns always take priority along with essential VA ben-

efits, intangibles such as recognition are important, too. Medals, parades and memorials are all part of the package, but so is a proper place in history. Rightfully so, like all of their predecessors, Persian Gulf War vets want to be remembered for achieving something meaningful.

Whether in the Army, Navy, Marines, Air Force or Coast Guard, each and every veteran of Desert Storm played a part in a history-making event. Some 695,000 Americans served in the Kuwait Theater of Operations during the buildup and war. A total of 146 died by hostile action and another 228 from accidental causes, with 467 wounded.

Despite its mercifully short duration, the war was a model military operation. Political decisions bearing on the ultimate outcome are no reflection on the troops. They accomplished their objectives without fail and on schedule. That is what should be remembered 20 years later and into the future.

This month's commemorative issue of *VFW Magazine* provides a glimpse of what took place in Saudi Arabia, Kuwait, Iraq, their offshore waters and airspace. A few units, actions and individuals have been selected to represent the whole. A book or books only can present the full picture. Nonetheless, this issue will provide a feel for the service of yet another generation of war vets.

Persian Gulf War veterans have long since joined VFW ranks. They are Post and Department Commanders, as well as full-time VFW employees (see page 26 of *VFW Magazine*). They are destined to leave their mark on the organization.







### Veterans Honoring Veterans

On October 2, 2010, it was a great honor and my pleasure to act as a guardian/escort for several WWII veterans who traveled to Washington D.C. to visit the WWII Memorial. The trip was a coordinated event sponsored by Pride and Honor Flight of Michigan, facilitated by Jack and Faye Wiseley.

A total of 73 WWII veterans and 28 guardians made the trip. As a VFW Post service officer, I am always looking for opportunities to assist our comrades in any way I can. I was the guardian for four WWII Veterans on the trip. Two of the veterans, Jack Eron of Ludington, Michigan and Clyde Sell of Columbiaville, Michigan, I had not previously met. Both of these men were U.S. Navy veterans serving in the Pacific. Two additional veterans, Del Dunn, served in the U.S. Army as a combat engineer in Germany; Bob Vasold served in the U.S. Marine Corps and was in the first assault wave for the Battle of Okinawa.

It was a royal greeting when The Southwest Airlines flight landed in Washington, D. C. to an ark of honor by water snorkels as the plane taxied in. Once departing the plane, there were hundreds of appreciative citizens at the arrival gate cheering and shaking the hands of the de-boarding veterans. 




