**Special Notice from Quartermaster General Robert B. Greene \***  
**Completion of IRS Form 8822-B:** "In January 2014, the Internal Revenue Service (IRS) began requiring entities with an Employer Identification Number to file IRS Form 8822-B to report the latest change of address or responsible party. Form 8822-B must be filed within 60 days of the change. **The purpose of form 8822-B is to notify IRS if you changed your business mailing**

**address, your business location or the identify of your responsible party.** A responsible party is the person who has a level of control over the funds or assets of the organization. For VFW purposes, that would be the quartermaster. So when the Department, District or Post has a change in Quartermaster leadership, this form must be filed within the 60-day time frame. IRS Form 8822-B and its instructions can be found at the following link: <http://www.irs.gov/pub/irs-pdf/8822b.pdf>

**The form will require the following information from the organization:** (1) Legal name of the organization, (2) Old mailing address, (3) Employer Identification Number, (4) New mailing address, (5) New Business location, if different from mailing address, (6) Old name of the responsible party (2013-2014 Quartermaster), (7) New

It was a blessing to see so many of you at our past Department Convention and I hope that your summer was enjoyable. We have much to accomplish this fiscal year and with teamwork it is certainly possible. I know you are about ready to turn the page [grin], but please be patient and read on.

In the spirit of late summer/early fall, it is appropriate to share the following... As a child, I used savor the days of summer. They passed by very quickly and were often filled with amazing memories and/or profound life lessons. One such summer included a week and a day at a West Michigan Girl Scout Camp with a program entitled, 'Potpourri.'

The 'Potpourri' option included marching over 12 miles throughout the back woods and partly live off the land. The objective of the program was to build leadership, enhance teamwork abilities, and complete the trip. Our group included 11 girls, the eldest being 14, and two adults — camp counselor and her younger assistant. We started with the typical Girl Scout Camp fun for four days, including chores, songs, patriotic duties, and then proceeded to start our trek into the forest.

We brought a horse and wagon, our sleeping bags, pillows, 4 tents, and some personal and camp supplies. The private items included clothes, toiletries, and other personal affects. In my case, it was an issue of 'Tiger Beat' magazine featuring several teen idols of the time, for which I was given 50¢ for them to view and then enter the 'write to your teen dream' contest. [Writers note: Please don't judge



too harshly; I was an enterprising kid.] Camp supplies included the usual camping fare for living in the outdoors as well as horse items.

The trip began with lots of complaining about the walking, the heat, etc. Our group was divided into 3 cliques and did not perform well together. We had checkpoints each night to house the horse, but no quarter for us and we were quarrelsome and hungry. Still, our group's members decided it would be best to continue, as the program's completion was an achievement held in high regard. The last 3 days of our food supply included a bevy of onions, bagels, and generic lemonade. So, we ate wild carrots, cattail roots, onions and bagels. By the way, even with a thick coating of lemonade drink mix, onions are still onions.

Instead of it degenerating into a Lord of the Flies construct, through mutual support garnered via walking and camp tending — and rather constant teeth brushing — we somehow became a team. Although not fully united, we managed to find humor and joy in the adversity. This experience was one I reflected upon years later in basic training. ## LEGISLATIVE DIRECTOR

VFW National web site [www.vfw.org](http://www.vfw.org) has a VFW in DC page that contains all the information we need to be involved in legislative issues that affect us as veterans and VFW members. All members are encouraged to visit this page to stay current on all legislation affecting veterans.

There is a wealth of information on this site.

All members should sign up for the Action Corps Weekly, formerly the Washington Weekly. This can be done on the web site. You will have this sent to your e-mail inbox every Friday. It also contains legislative alerts about pending legislation that we need to take action on to notify our legislators of our support for these issues. Again, this can all be done on the VFW national web site, [www.vfw.org](http://www.vfw.org), VFW in DC page.

Commander-in-Chief John Stroud has asked that all eligible veterans join the VFW and join us in the fight for our benefits for veterans and members of our armed forces. Comrades, we can use our legislative efforts as a recruiting tool to sign up new members. If a prospective member asks, as they often do, what we do in the VFW, we can tell them that one of the important things we do is to fight for their rights and benefits as veterans and members of our armed forces. We must understand that all our benefits and rights such as VA disability, VA health care are funded by the federal and



state government in legislation and the budget process and if we don't continue the fight, our hard fought benefits will be eliminated or reduced. The veterans who preceded us from WW1, WW11, Korea, and Vietnam have fought for these benefits and we must continue the fight or face the possible loss or reduction of these important benefits and rights.

Through VFW action Senate bill S 1982 has been introduced. It has been called the most important veterans legislation in decades. It is currently in committee and it addresses most of the issues we have been fighting for, regarding VA benefits and current and retired armed forces pay and benefits. The Senate has introduced S 2450, VA health care and accessibility, which addresses the current crisis in VA health care. It is currently in conference committee. We need to show our support for these two very important pieces of legislation.

At the state level, VFW is currently involved in proposed legislation that will allow active duty, reserve members and veterans to receive in state tuition rates at Michigan universities, colleges and community colleges. This will require



a ballot proposal as it amends the state constitution. We are working to get this on the November ballot. Also, recently Governor Snyder signed a law restoring tuition assistance to Michigan National Guard members. VFW was involved in this legislation.

Every important legislative victory we have had affecting veterans the VFW has been involved in. The list of VFW legislative victories dates back to 1917. We need to make prospective members aware that our strength is in our numbers. We need to go to our legislators as a voting bloc to assure them we will vote for the candidates that support our agenda as veterans and armed service members.

At the district and post level, all legislative chairs should let the members know who their representatives are in the state and federal legislatures. Encourage all members to sign up for the Action Corps Weekly, and take action by contacting their legislators on any legislative alerts sent by the VFW National Legislative program. Encourage your Men's Auxiliary to get involved in supporting our veterans issues. Remember that many of our members are very tech savvy, especially younger members, and

prospective new members. Many of our members already use Facebook and other social media. If your post has a web site or Facebook page, put information regarding current legislative initiatives on these sites and encourage members to take action.

It has been said all politics are local. We need as VFW members to be involved at the grassroots level, to contact our legislators by phone, by letter, by E-mail on issues concerning the VFW and our hard fought for benefits and rights. We can never assume that we are guaranteed these. One of the priorities in our legislative program is for our members to be actively involved at the grassroots level. Legislative chairmen at the post and district level should schedule training to show members how to navigate the VFW in DC web page. This can be done at post and district meetings.

In closing, I would like to thank our members for their support of our legislative activity, and encourage all members to get involved in the fight for our hard earned benefits and rights as veterans, armed service members and VFW members.

SUCCESS STORY**

When a veteran walks into the office seeking assistance you never know what might happen by asking a few additional questions. In the following case the outcome was

significantly enriching to the veteran.

An elderly Korean War veteran walked into the VFW service office at one of the VA Medical Centers. He was upset because the VA was charging him a co-pay on medications he should have been receiving at no cost. The same time this occurred our service officer was training a newly hired employee and had been explaining the finer points on how to conduct an interview. He emphasized the importance of asking probing questions to determine if the veteran was eligible for any other benefits. It was extremely fortunate for the veteran our service officer did exactly that.

Noticing large scars on the veteran's arms the service officer asked what had happened. The veteran explained the wounds were inflicted when his unit was overrun. A Chinese soldier stood over him and shot the veteran from right to left with an assault rifle. Miraculously no vital organs were hit, but the veteran sustained multiple gunshot wounds to both arms. As a result of these wounds the VA awarded the veteran multiple 0 percent ratings for scars.

Our service officer was astonished the veteran was not receiving a monetary award for his wounds. The arms were obviously atrophied which is an indication of muscle loss. The service officer

reported his findings to the most senior service officer, as well as another service officer having experience with this type of issue. A claim was then submitted citing a clear and unmistakable error on the initial evaluation which was now 60 years old.

Upon submission to the VA the claim was reviewed at the Regional Office by a Rating Veterans Service Representative. Unfortunately the rater found no reason to reverse the earlier decision and upheld the original findings. Unsatisfied with the decision, the service officer contacted the VFW representative in Washington, D.C. who specializes in this type of claim. When the Appeals Consultant reviewed the veteran's service treatment records along with the original rating decision he knew he had a winner on his hands.

Consulting the Code of Federal Regulations in effect at the time, the Appeals Consultant determined the veteran should have been rated at 30 percent per arm due to the wounds being through-and-through, meaning the muscle tissue had both an entry and exit wound. Additionally, the veteran had suffered fractures to at least one arm. The wounds should have been rated as moderately severe and our representative in Washington, D.C. informed the VA of his findings.

A VA official in Washington, D.C. reviewed the Appeals Consultant's findings and agreed, overturning the Regional Office decision. The veteran was awarded a total of 60 percent going back to 1953! A check for over \$349,000 was recently deposited in the veteran's checking account. Though decades late, the veteran was extremely grateful to be rightly compensated for his injuries!

**Advocating For Others**

At our recent State Convention and again at the Veterans Training Seminar (VTS) at Camp Trotter I was approached by three or four comrades who expressed frustration with billing issues originating with care from a Veterans Affairs Medical Center (VAMC) facility. One of these individuals complained he was being billed from a third party even though the VAMC had ordered the procedure and set up the appointment. Our comrade was receiving intimidating notices from the third party threatening to send his account to collections.

I will attempt to present information to help those who interact with the healthcare side of the VA. I will not be able to cover all the needed ground in one article so this will serve as an introduction into this very important topic.

First, realize the Department of Veterans Affairs (VA) consists of three distinct entities: The VBA (Veterans Benefits Administration) which handles claims such as for compensation and pension as well as education, the VHA (Veterans Healthcare Administration) which provides healthcare, and the Veterans National Cemetery Administration which provides final resting places and serves as a lasting tribute to those who have served and chose to be buried in a national cemetery.

I will concentrate on the VHA since this is the source of current frustrations. To be eligible to receive VA healthcare a veteran should first be enrolled in the VA healthcare system. This is done using a

VA Form 10-10EZ. You can apply online, in person, over the phone, or by mail.

To apply online go to [www.va.gov/Healthbenefits](http://www.va.gov/Healthbenefits) and follow the prompts. If you apply online the VA will verify your service. If you apply in person or by mail having your DD214 available can help speed the process.

To apply in person, go to your local VA health care facility. Complete and submit VA Form 10-10EZ, Application for Health Benefits to the Enrollment Coordinator or eligibility/health benefits office.

To apply by phone call 1-877-222-VETS(8387), Monday-Friday, 8:00 am to 8:00 pm EST. Within 3-5 business days you will receive the completed VA Form 10-10EZ, Application for Health Benefits for you to review, sign and return.

To apply by mail pick up an application at your local VA or download the application online. Complete the application (be sure to sign it) and place in the mail.

A veteran who is not service connected for any injuries or illnesses must meet certain eligibility criteria. The most important element is income or more appropriate the lack of income. If one cannot afford outside healthcare enrollment in the VHA is quite probable. Another element is whether or not a veteran has other insurance available. Again, lack of insurance improves one's chances of being enrolled in VHA.

In the next issue of the Michigan Overseas Veterans I will address the steps to take when one encounters billing problems with respect to VHA care.







Here are some statistics from a sales study (and you are selling memberships) : 48% never follow up on a prospective member, 25% make a second contact, 12% make a third contact, and only 10% make more than three contacts. The survey goes on to indicate the following: 2% say yes the first time, 3% the second time, 5% the third contact, 10% on the fourth contact, and finally 80% say yes on the fifth to twelfth contact. So what does this tell us? Keep Asking! For all of you who have children, you know the power of persistence. When was the last time they asked for something and you said no and they stopped asking? The answer is probably never, they keep asking don't they and we need to do the same. Always carry a business card with your contact information or an application with you where ever you are and look for opportunities to find new members.

## Veteran Expo to provide information on presumptive diseases, benefits and more

Chronic B-cell Leukemia. Hodgkin's disease. Ischemic heart disease. Prostate and respiratory cancers.

Although the Vietnam War ended more than 40 years ago, many veterans from that era still carry the war with them, in part due to health conditions related to exposure to Agent Orange and other herbicides used in support of military operations. The U.S. Department of Veterans Affairs (VA) recognizes certain health problems as presumptive diseases associated with that exposure, and veterans and their survivors may be eligible for benefits for these diseases.

"New research and medical advances have contributed to more than 50 changes to the benefits eligibility for Vietnam-era veterans in the last 15 years," said Michigan Veterans Affairs Agency (MVAA) Director Jeff Barnes. "Veterans who haven't looked back to the VA in a number of years could be missing out on valuable benefits."

Barnes added that anyone who has served in the U.S. military, anytime and anywhere, is eligible for some level of benefit for their service.

Veterans of all eras are encouraged

to attend one of the Michigan Veteran Expos to learn more about presumptive diseases and available state and federal benefits and resources. Upcoming Expos will be held in Grand Rapids Sept. 5-6 and Detroit Nov. 7-8. Hosted by MVAA, these free events will serve as one-stop shops where veterans and their families can learn about employment and education opportunities, take advantage of healthcare screenings, meet with accredited benefits counselors and learn about recreation programs and other available resources.

In addition, Hiring Our Heroes will host a veteran employment fair on Saturday at each Expo. Expo hours are 11 a.m. to 8 p.m. on Friday and 9 a.m. to 3 p.m. on Saturday. Online registration is available at: [www.events.mphi.org/vetexpo](http://www.events.mphi.org/vetexpo).

MVAA serves as the central coordinating point, connecting those who have served in the United States Armed Services and their families, to services and benefits throughout the state of Michigan. This program is under the Ladies Auxiliary, and eligibility requirements are the same as the Ladies Auxiliary: you must be a daughter, granddaughter, stepdaughter (who attained the status prior to the age of sixteen and for whom duties of parent were performed) sister, or stepsister (who attained the status prior to the age of sixteen) of persons who were are/were eligible for membership in the Veterans of Foreign Wars. Junior Girls are between the ages of 5—16 years old.

The unit leaders are members of the Ladies Auxiliary to the Veterans of Foreign Wars and they promote the Ladies Auxiliary Programs, such as Americanism, Veterans and Family Support, Legislative, Hospital and Cancer Aid and Research. Changes in Eligibility:

Membership is open to – VFW Ladies Auxiliary Members are – Wives, Widows, Mothers, and Stepmothers (who have performed the duties

of a parent), Grandmothers, Daughters, Granddaughters, and Stepdaughters (who attained that status prior to the age of sixteen and for whom the duties of parent were performed), Sisters, Half-sisters, and Stepsisters (who attained that status prior to the age of sixteen) – of persons who were or are eligible for membership in the Veterans of Foreign Wars of the United States.

If you seen this statement above, you might have noticed that the word “Foster” has been deleted. It was brought on the floor at the recent National Convention and passed to remove the word “Foster” and is no longer a consideration for eligibility. However, those that are members of the Ladies Auxiliary or Jr. Girls under that eligibility are grandfathered and no action needs to be taken.

We all have different reasons why we join this great organization, but

here are a few other reasons to join the Ladies Auxiliary to the Veterans of Foreign Wars of the United States of America:

1. To honor the service of a family member.
2. To promote patriotism within your community to all citizens young and old.
3. To participate in programs that bring family and community members together for worthwhile projects.

5. To be the voice of those Veterans that gave the ultimate sacrifice so we can all live in a democracy.

## Air Force Veteran Elected To Lead America's Largest Combat Veterans Organization

New VFW National Commander  
Vows to Defend Freedom's Defenders



KANSAS CITY, Mo. (July 24, 2014) — The Veterans of Foreign Wars of the United States concluded its 115th national convention yesterday with

the election of the new VFW National Commander, John W. Stroud.

Stroud served in the U.S. Air Force from 1976-1997, including a tour in Korea in 1992-1993 with the 51st Fighter Wing at Osan Air Base as a Flight Operations Superintendent. His decorations include four Meritorious Service Medals, three Air Force Commendation Medals, three Air Force Achievement Medals, the Korea Defense Service Medal and the National Defense Service Medal.

He is a resident of Hawthorne, Nev., and a Gold Legacy Life Member of Post 2313, and has served the VFW in a number of leadership positions including Nevada Department Commander and Chairman of the National Veterans Service Committee.

During his acceptance speech, Stroud addressed the recent VA crisis stating, "the VA is a health care system worth saving that right now must identify and fix what's broken ... that needs to hold people appropriately accountable to the fullest extent of the law ... and a system that must restore the faith of veterans in their VA. He added that he is confident Acting VA Secretary Sloan Gibson and nominee Bob McDonald—if confirmed—will not make the same mistake as the previous VA Secretary who simply trusted his employees to the point of his demise.

Stroud recounted his first experience with the VFW, stopping in Post 10047 in Las Vegas, Nev., after seeing a sign that read 'Active Duty Military Welcome.' Dressed in fatigues, he entered the Post and was immediately welcomed. Surrounded by his comrades, he learned of the organization's many programs and services, and he knew he wanted in.

"Comrades, I share my story to encourage you to tell your own stories to others. A great part of the VFW story involves the relevance between different generations, and the ability to educate others about who we are, what we do, and

who we do it for," he said.

Stroud had high praise for members' work and VFW programs, citing several outstanding instances of disaster relief, troop support and veterans resource efforts. He commended those who worked with the U.S. European Command to operate a Visitor's Center for hundreds of American D-Day veterans and thousands of visitors who were in Normandy for the 70th anniversary of the landing, and praised the Ladies Auxiliary for its donations to cancer research which now total \$30 million.

"One of the best things about being a National Officer is I get to brag about the VFW wherever I go ... to the troops, to veterans, their families, nonveterans and politicians, too," he said.

Stroud stressed the importance of reaching out to Iraq and Afghanistan veterans and educating them on what the VFW is all about. The camaraderie the VFW offers, as well as its services help ease their transition to civilian life. Further, the VFW fights to ensure Congress and the Administration keep America's promise to care for them, long after their successful transition.

"To this very day they don't know that it was the VFW who led the charge to create a new GI Bill... a Family Caregiver Act... Traumatic Injury Insurance... a bullet-proof Stolen Valor Act... concurrent receipt... a lower Guard and Reserve retirement age ... and advance appropriations for VA health care," he explained.

Stroud is the second Nevadan to be elected as VFW National Commander. He graduated with honors from Embry-Riddle Aeronautical University in 1990 with a Bachelor of Science degree in Professional Aeronautics. He worked as the Mineral County Building Official and is now retired. He is also a member of the American Legion, the Elks, and is a Life member of the Disabled American Veterans, the Military Order of the Cootie and the VFW National Home for Children.

Stroud will log thousands of miles within the U.S. and internationally to promote the VFW, veterans' issues and quality of life initiatives for active-duty, Reserve and Guard members.

Also elected were Senior Vice Commander-in-Chief John A. Biedrzycki, Jr. of Robinson Township, Pa., and Junior Vice Commander-in-Chief Brian J. Duffy of Louisville, Ky.

Vietnam War, including personnel who were held as prisoners of war or listed as missing in action, for their service and sacrifice on behalf of the United States and to thank and honor the families of these veterans.

- 2.To highlight the service of the Armed Forces during the Vietnam War and the contributions of Federal agencies and governmental and nongovernmental organizations that served with, or in support of, the Armed Forces.
- 3.To pay tribute to the contributions made on the home front by the people of the United States during the Vietnam War.
- 4.To highlight the advances in technology, science, and medicine related to military research conducted during the Vietnam War.
- 5.To recognize the contributions and sacrifices made by the allies of the United States during the Vietnam War.



## President Signs Critical Veterans' Legislation Into Law

### VFW on hand for signing of Veterans Access, Choice and Accountability Act

August 07, 2014 – The Veterans of Foreign Wars of the United States (VFW) was on hand today at Fort Belvoir, VA as the president signed H.R. 3230, the Veterans Access, Choice and Accountability Act of 2014 into law. The newly signed law will provide the Department of Veterans Affairs (VA) with an additional \$15 billion of emergency funding to ensure veterans who cannot be seen by a VA doctor will not be forced to wait months for care. It will also allow VA to begin building capacity and regain veterans' trust by hiring more physicians and building needed infrastructure and allowing the Secretary to fire top executives who don't have veterans' best interest at heart.

"As early as 2002 the VFW has testified before Congress that veterans are waiting too long for care and that VA doesn't have the doctors and space needed to provide timely care," said VFW Commander-in-Chief John Stroud. "This legislation is a positive first step in putting VA back on track, but it will take decisive leadership within VA, as well as strong oversight from Congress and the veteran community to ensure our veterans receive the timely, quality care they have earned."

The VFW membership then passed a stern resolution at the recent VFW National Convention, telling Congress to either pass the bill before recess, or pay the consequences back home. This message

was quickly reinforced by the VFW's grassroots Action Corps, which sent nearly 32,000 messages to every Congressional office on Capitol Hill, insisting legislators take action.

"VFW members were rightfully outraged over the recent controversy, and today the voices of our members resonated strongly in Washington," said Stroud.

The Veterans Access, Choice and Accountability Act of 2014 also includes critical provisions expanding traumatic brain injury care programs for veterans; improving education benefits for surviving spouses; critical funding for 27 new or expanded VA Community-based Outpatient Clinics; and a provision offering veterans in-state tuition at the public college or university of their choice within three years of leaving active duty.

The new law comes in the wake of a nationwide scandal in which veterans and whistleblowers called attention to veterans languishing on appointment waiting lists at VA facilities. The scandal has led to widespread criminal investigations and the resignation of many top VA officials. When news of the scandal broke, the VFW mobilized its health care help line, 1-800-VFW-1899, encouraging veterans to call and share their experiences, and intervening directly with VA on behalf of more than 200 veterans who were waiting for care.

## VFW Calls For Boycott Until Mexico Releases U.S. Marine

### VFW To Apply Economic Pressure

WASHINGTON — June 25, 2014. The Veterans of Foreign Wars of the United States is calling for a nationwide boycott of Mexican products and travel until Marine Sgt. Andrew Tahmooressi is released from a Mexican jail.

"This combat Marine has been languishing away since he was arrested March 31 for allegedly crossing the border accidentally with three personal firearms that were legally registered in the States but not in Mexico," said VFW National Commander William A. Thien. "It

was a mistake, but so is the Mexican government's reluctance to release him unharmed back to the U.S."

As America's oldest and largest major combat veterans' organization, the VFW wants to apply economic pressure to the Mexican government because Tahmooressi's arrest and captivity is mirroring that of former Marine Jon Hammer, who was arrested for carrying an antique shotgun across the border in August 2012, despite having proper American paperwork. He

## VFW Comment On Senator Burr's Open Letter To Veterans

### Senator Burr's Allegations Are Mean-spirited and Profoundly Wrong

May 26, 2014 – This letter is in response to the open letter you made available for distribution late Friday, May, 23, 2014. First and foremost Senator, I will afford you the same amount of respect you demonstrated for the Veterans of Foreign Wars by the monumental cheap-shot and posturing you've engaged in by enlisting in an absolutely disgusting ambush style of politics. Without the courtesy or benefit of conversation or dialogue with me or the VFW Adjutant General regarding your disagreement with VFW's recent testimony to your committee, you chose instead to take the low road and question VFW's motives and levy a pejorative personal attack on VFW staff. Senator, this is clearly one of the most dishonorable and grossly inappropriate acts that we've witnessed in more than forty years of involvement with the veteran community and breaches the standards of the United States Senate. Your allegations are ugly and mean-spirited in every sense of the words and are profoundly wrong, both logically and morally. Quite frankly Senator, you should be ashamed.

The VFW staff you chose to rebuke and whose principles you have questioned walk the walk. They've been there, done that and some of them have the scars to show for it. Collectively, those same staff members have among them more than 47 combat deployments. This includes deployments to Vietnam, Somalia, Iraq and Afghanistan. Their awards include four Purple Hearts, sixteen Air Medals, Bronze Stars and a variety of other awards. Some rely on VA for their healthcare and residual treatment associated with their military service. They understand firsthand the problems existing within the system because, unlike the majority of people, they've been willing to do what others won't. Senator, that is exactly why we find your personal attack so disgusting.

The men and women working in our DC office are dedicated professionals. Importantly, they take the work they do personally. They do it because they care. I suggest you compare the more than exorbitant amount of days off you receive, including virtually the whole month of August, two weeks around Easter/Passover, and certainly not a single five-day work week to the often time long, arduous hours they put forth every week of the year. Surely, with all the issues and the current emergent need for solutions, you must have more important things to do than to assail the character, people and motives of America's VSOs?

Let me assure you Senator, our DC staff does not operate in a vacuum, or independently from its headquarters in Kansas City. The staff operates under the direction of me and the Adjutant General. The testimony that was provided to your committee was vetted and approved by me and the Adjutant General only after careful study and consideration. We don't act in hopes of grabbing a headline or securing an interview on cable news; our only agenda in this is to ensure the veterans of our nation receive timely and adequate healthcare. If you have issues then I suggest you contact either one of us directly.

The fact of the matter is this; every year the VFW, Disabled American Veterans, AMVETS and Paralyzed Veterans of

America have been trying to call attention to the issue, warning Congress of the consequences, and trying to work with Congress and VA on solutions.

Each year our organizations build an analysis of VA benefits and services known as the Independent Budget, and each year since 2005 the Independent Budget has warned Congress about the dangers of long wait times and care rationing due to improper resources, oversight and accountability.

Last year, and again this year, then-VFW Commander-in-Chief John Hamilton and I warned you and both the House and Senate Veterans Affairs committees about the dangers of long wait times. This decade of stern warnings has fallen on deaf ears.

There's no doubt that the culture within VA needs to change. In a letter to the President, we made it clear that he needed to take immediate steps and ensure necessary authority to Secretary Shinseki that will guarantee the status quo of protecting enmeshed and "untouchable" bureaucrats within the VA system cannot and will not continue. We urged him to provide him authority to impose the strongest disciplinary actions, including removal and prosecution whenever and wherever necessary, on any VA employee who would abdicate their responsibilities and have a hand in the mistreatment or abandonment of those who have earned timely and adequate healthcare.

Clearly, you were not listening during VFW's testimony. Nowhere did we suggest that we were interested in protecting anyone. I suggest you read the transcript. We find it especially specious that you seek to point fingers without at least an acknowledgement of some responsibility by Congress in all of this. Your assumption that we do not listen to what our members have to say is insulting. We spend most of the year traveling to and visiting VFW Posts world-wide. We have direct contact and speak at length with our members. We listen. And what you should know is this; that there is huge, and growing sentiment within most of the veteran community regarding the inaction of Congress, because they are keenly aware, (if the past is any guide), they will enact no budget, no regular appropriations bills, nor other key legislation.

If we've been remiss in anything Senator, we've been remiss in being too polite with Congress. For years, the VFW has come to Congress with hat in hand and for years, we've heard the same old story. You can be assured Senator, that you've done a superb job in showing us the error in our ways. You can also be assured that in the future, we will spend a substantial percentage of our time seeking to inform our members and our constituents of the repeated failure to act by our elected officials. We will not stand by and let our members be distracted by rhetoric or finger-pointing and we certainly won't abide our veterans being used as political footballs. And you can be sure that we will let our membership know the low-regard you hold for their organization.

wasn't released until four months later. Thien said the VFW tried the politically polite route by twice asking President Obama to contact Mexican President Enrique Pena Nieto, but a phone call specifically about the Marine sergeant never took place. Now that Tahmooressi is approaching his third full

month in jail, the VFW national commander said it's time to take the gloves off. "This is about politics, and if my government won't do anything, then I guess we need to let the power of the purse take over. No products, no travel, a total boycott ... then maybe a dialogue will start."

**Two Generations of Vietnam Veterans in the Same Family Fight for Justice: And Win**

The Veterans Consortium Pro Bono Program provides free, volunteer attorneys to represent veterans appealing their benefits denials to the U.S. Court of Appeals for Veterans Claims

Mr. McManus, a career Air Force noncommissioned officer, had served in Vietnam from 1966 to 1967. In 1985, he filed a claim for benefits for diabetes and an award under the Nehmer decision that awarded disability benefits to Vietnam veterans suffering from illnesses scientifically linked to Agent Orange exposure. Sadly, he succumbed to complications from diabetes and heart disease in 1991, while his claim was still pending.

His son, also a Vietnam veteran (he served in Vietnam as an Army medic from 1970 to 1971), decided to pursue his father's claim himself. "I started by getting a computer and surfing the Web," he recalls. For five years, from 2004 to 2009, Mr. McManus filed all the briefs for his appeal pro se, again and again hearing that his father's diabetes was not a condition that was eligible for benefits. Again and again, he looked for counsel who might help him appeal the VA denials, without success. "No one got back to me, or they didn't do this kind of work."

For more than five years, he painstakingly filed his own claims, enduring rejection after rejection from the VA.

What could have been another in a long list of discouraging events instead became a turning point, when he appealed the case to the U.S. Court of Appeals for Veterans Claims: "That's when the judge said it would be better if an attorney handled things for me at this point." The Court issued an order requesting the Veterans Consortium Pro Bono Program ([www.vetsprobono.org](http://www.vetsprobono.org)) investigate the possibility of representing Mr. McManus. The program responded to the Court's order, evaluated Mr. McManus's case, and assigned a volunteer attorney to represent him.

When [the Pro Bono Program volunteer attorney] got on board it was like a whole weight was lifted off me," Mr. McManus says of the moment his attorney took over his appeal for the accrued benefits and an Agent Orange award owed his late father. "The Pro Bono people organized things really well. They took my thoughts and made them go from regular TV to high-def."

After reviewing the case files, Mr. McManus' attorney determined that the Board of Veterans Appeals had erred in finding that his father did not have diabetes after its own regional office had determined that he did. The Board had also been wrong to contend that the Agent Orange award law did not apply, ruling that the elder Mr. McManus had had no claim pending when he died. In fact, the late Mr. McManus had filed a timely claim.

In light of the volunteer attorney's arguments, substantiated by VA's own records, the Court reversed the Board—a rare occurrence (most cases are remanded).

I could not have asked for a better ending," says Mr. McManus, now 61. "We're not quite through, but I was very pleased with how the Pro Bono people came in and took things to the next level. Being a veteran, this mattered a lot to me—and I hope it will be a case that others will see and can use."



## MGCB and Governor Issue Emergency Rules Effective Immediately

On Thursday, July 3rd, Governor Snyder and the MGCB issued Emergency Rules that contain many of the provisions contained in the rule set that the Court of Claims enjoined in May.

**A summary of the Emergency Rules can be found here:**

- 1) The Emergency rules are being adopted to protect the health, safety and welfare of Michigan citizens;
- 2) the argument is that the increased risk to the charities that they will be victims of criminal activity, including fraud and theft is the specific threat;
- 3) the Executive Director can authorize up to 2 millionaire parties per location per day and there shall be no more than 4 millionaire part event days per week per location;
- 4) a qualified organization may not enter into an agreement with the location owner or lessor other than those addressed in the written rental agreement approved by the Executive Director;
- 5) charities must have 3 bona fide members on site at all times;
- 6) the Executive director may determine the permissible hours of the day during which millionaire parties can be conducted.


How does this affect the injunction that was obtained by MiCGA, charities, locations and suppliers who filed to enjoin the rules from May, 2014? That will be up to the Judge who has been assigned the case. This decision has not been made yet. We will notify members as soon as additional information becomes available.

In the meantime, it is critical that you contact the House of Representatives and let them know that you are displeased that Governor and Executive Director are trying to circumvent the judicial process and the House has to act when they return in September on SB878! Even if you called before, this new development is definitely worthy of another call to the House.

## Ceremonial Rifles and Static Displays

There seems to be some confusion surrounding the US Army Ceremonial Rifle and Static Display program. Hopefully this article will help to clear up the confusion. First let's talk about the Static Displays. Static Displays can be anything from a M60 tank to a helicopter. Due to the high dollar amount of the display items (a condition of the conditional deed of gift that your post signed), an annual certification of Army material status form must re-filed every year (no later than the agreement date on the conditional deed of gift) which certifies that 1) the static display is still needed, maintained in a safe and clean condition so that its appearance reflects favorably on the US military 2) is in poor condition (when the restoration will take place and when it will be done) 3) is no longer needed and request disposition instructions. This certification form must be notarized prior to submission. If the display is no longer needed, the US Army will arrange to have it removed from the property. It may take up to 6 month before this happens. If your post does not comply with the conditions set forth in the conditional deed of gift, the display may be removed from the property and the costs associated with the removal may be charged to the post.

Ceremonial rifles used to require an annual certification but the Department of the Army and the General Services Administration (GSA) have decided that due to the low dollar amount of each rifle they only need to be certified every 3 years (triennially). This certification form is a little different than the one for the static display. On this certification, if your post does not need all or part of the weapons or needs replacement weapon, put an asterisk (\*) next to the listed rifle and you will be contacted with disposition instructions. If weapons need to be returned, the post will be issued a prepaid shipping label. The post will have

to pay for the container to ship them in (cardboard, wooden crate, etc).

Both the static displays and weapons are the property of the US Army and have been loaned to the posts. Under the conditional deed of gift that was signed by the post, the display pieces and weapons CAN NOT, I repeat CAN NOT be given, loaned, rented, leased (or whatever you want to call it) to any individual, organization (VFW, American Legion, etc) or municipality. Your post is responsible for these items.

If your post was issued weapons and they are missing, it is the responsibility of the post to contact the local police department, file a report and submit that report to the US Army TACOM. Since I work for the US Army TACOM I have asked Department Commander Croyle to be the liaison between the Posts and TACOM. I am asking that you send me all the certification forms, police reports or contact me with questions. Once I receive the information I will be in contact with the display coordinators (who works that position part time) and make sure everything is documented correctly. My contact information is:



The VFW volunteers more than 11 million hours annually at VA's 1,400 medical facilities.

We award \$3.2 million annually in 6th through 12th grade Voice of Democracy and Patriots Pen patriotic scholarships.

We have provided 7.5 million free telephone connections between deployed personnel and their loved ones back home.

We have hosted 2 million military and their families at departure and homecoming ceremonies.

Through our UNMET Needs program we have provided almost \$5 million in grants to help more than 3,500 military families through emergency financial situations.

No one does more for our veterans isn't just a catchy phrase, it is what we do as an organization...It's who we have always been.
